ACCESS/SUCCESS

SB-686 (Allen) - California Promise Neighborhoods Act of 2019.

Establishes, contingent upon an appropriation, the California Promise Neighborhood Grant Program, to be administered by the California Department of Education (CDE), for the purpose of awarding up to 20 grants of up to \$5 million each, on a competitive basis, to eligible entities to implement a comprehensive, integrated continuum of cradle-to-college-to-career solutions, including academic, health, and social programs, and family and community supports. The bill was held in the Assembly Appropriations Committee.

Status: Assembly-Died - Appropriations

ACCOUNTABILITY

AB-1240 (Weber) - School accountability: local control and accountability plans: state priorities: pupil achievement.

Revises the definition of the pupil achievement state priority for purposes of school district, county office of education, and charter school local control and accountability plans (LCAPs) to also include the percentage of pupils who have successfully completed courses that satisfy the requirements for both (1) entrance to the University of California (UC) and the California State University (CSU) and (2) career technical education (CTE) sequences. Chaptered.

Status: Chapter 783, Statutes of 2019

AB-1684 (Maienschein) - Pupil literacy: statewide professional learning infrastructure.

Requires the California Department of Education (CDE) to develop and implement a professional development program to support educators in teaching literacy and reading, including providing dedicated funds to schools identified by the state's accountability system as needing special English language arts (ELA) support, consistent with the state's "system of support" for schools. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

ADULT EDUCATION

SB-554 (Roth) - Public schools: adult school pupils: Advanced Scholastic and Vocational Training Program.

Allows the governing board overseeing an adult education program to admit adult school pupils pursuing a high school diploma or the equivalent as special part-time or full-time dual enrollment students. Chaptered.

Status: Chapter 528, Statutes of 2019

AFTER SCHOOL PROGRAMS

SB-346 (Jackson) - After school programs: Distinguished After School Health Recognition Program.

Re-establishes the Distinguished After School Health (DASH) Recognition Program, to be administered by the California Department of Education (CDE). The bill was held in the Assembly Appropriations Committee.

Status: Assembly-Died - Appropriations

SB-1125 (Portantino) - Local educational agencies: educational programs.

Requires the California Department of Education (CDE) to review funding for all after school programs offered in the state, including, but not limited to, the After School Education and Safety Program and programs supported by federal funding, and to, by regulation, provide flexibility to school districts to use funds provided for after school programs for before school programs if that flexibility is not prohibited by the After School Education and Safety Program Act of 2002. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-1085 (McCarty) - After school programs: substance use prevention: funding: cannabis revenue.

(1) Encourages After School Education and Safety (ASES) programs, the 21st Century Community Learning Centers (21st CCLC) programs, and the 21st Century High School After School Safety and Enrichment for Teens (ASSETs) programs to establish programs that are designed to educate about and prevent substance use disorders or to prevent harm from substance abuse; (2) requires the State Department of Health Care Services (DHCS) to enter into interagency agreements with the California Department of Education (CDE) to administer those programs and allocate their funding; and (3) specifically authorizes DHCS to consider selecting those programs for funding from the Control, Regulate and Tax Adult Use of Marijuana Act. The bill was vetoed.

Status: Assembly-Vetoed

AB-1725 (Carrillo) - Before and after school programs: maximum grant amounts.

Repeals the maximum grant amounts for the After School Education and Safety (ASES) and High School After School Safety and Enrichment for Teens (ASSETs) programs, and the minimum grant amount for the 21st Century Community Learning Centers program, and instead requires the California Department of Education (CDE) to establish an annual process and methodology for determining those amounts and their daily rate of funding per pupil by July 1, 2022, as provided, on the basis of the amount of funding available for each program. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

ALTERNATIVE EDUCATION

SB-1149 (Hueso) - Pupil attendance.

Authorizes school districts to use available funds to establish attendance recovery programs for pupils who are foster youth, pupils who are homeless children or youth, and pupils with exceptional needs, who are enrolled at schools maintained by the school district to prevent these pupils from being chronically absent. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-1097 (Holden) - Pupil instruction: credit recovery programs: report.

Requires the California Department of Education (CDE), by July 1, 2021, to provide a report to the Governor and Legislature on credit recovery programs. Chaptered.

Status: Chapter 451, Statutes of 2019

ASSESSMENT

AB-751 (O'Donnell) - Pupil assessments: Pathways to College Act.

Requires the Superintendent of Public Instruction (SPI) to approve one or more nationally recognized high school assessments that a local education agency (LEA) may, at its own discretion, administer in lieu of the grade 11 Smarter Balanced Summative Assessment (SBAC), commencing with the 2021-22 school year. The bill was vetoed.

Status: Assembly-Vetoed

AB-1233 (Smith) - Advanced placement examinations: fees.

Establishes a grant program, administered by the California Department of Education (CDE), for purposes of awarding grants to cover the costs of advanced placement (AP) examination fees for eligible low-income high school pupils or foster youth high school pupils. The bill was vetoed.

Status: Assembly-Vetoed

ATHLETICS AND PHYSICAL EDUCATION

AB-908 (O'Donnell) - Pupils: extracurricular activities: work permits.

(1) Authorizes a school district to extend its probationary period for pupils to demonstrate satisfactory progress, for purposes of extracurricular and cocurricular activities, through the conclusion of the 2020-21 school year; (2) authorizes documentation required for purposes of pupil work permits to be submitted electronically during an extended school closure due to a natural disaster, pandemic, or other emergency; and (3) prohibits a work permit from being denied based on a pupil's grades, grade point average, or school attendance when the pupil's school has been physically closed for an extended time due to natural disaster, pandemic, or other emergency. The bill was an urgency measure. Chaptered.

Status: Chapter 64, Statutes of 2020

AB-1214 (Melendez) - School employees: training: cardiopulmonary resuscitation.

Requires a local educational agency (LEA) to offer a course in cardiopulmonary resuscitation (CPR) and requires a school district or charter school, if it elects to offer any interscholastic athletic program, to have personnel with a valid certification of CPR training to be present at the athletic program's on-campus activities or events at all times. The bill was vetoed.

Status: Assembly-Vetoed

ATTENDANCE/TRUANCY

SB-849 (Portantino) - Pupil attendance: excused absences: mental or behavioral health.

Specifically adds "for the benefit of the mental or behavioral health of the pupil" to the list of categories of excused absences for purposes of school attendance. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1149 (Hueso) - Pupil attendance.

Authorizes school districts to use available funds to establish attendance recovery programs for pupils who are foster youth, pupils who are homeless children or youth, and pupils with exceptional needs, who are enrolled at schools maintained by the school district to prevent these pupils from being chronically absent. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

CAREER AND TECHNICAL EDUCATION K12

AB-1558 (Ramos) - Apprenticeship programs: career fairs.

Requires school districts or schools planning college or career fairs to notify apprenticeship programs in their county utilizing contact information from the database of approved apprenticeship programs published by the Division of Apprenticeship Standards on its internet website. The bill was vetoed.

Status: Assembly-Vetoed

CHARTER SCHOOLS/SCHOOL CHOICE AND TRANSFERS

SB-126 (Leyva) - Charter schools.

Requires charter school governing boards to comply with a variety of the same open meeting, conflict-of-interest, and disclosure laws as traditional school district governing boards. Chaptered.

Status: Chapter 3, Statutes of 2019

SB-488 (Morrell) - Elementary and secondary education: Cal-Grant K-12

Award: certificated employee salaries: open enrollment: private school tax credit.

Deletes residency requirements and specifically authorizes K-12 students to attend any school in the state. Senate Education, not heard.

Status: Senate-Died - Education

SB-756 (Durazo) - Charter schools: moratorium.

Prohibits the approval of new charter schools until January 1, 2022. Senate floor, inactive file.

Status: Senate-Died

SB-1119 (Morrell) - Pupil enrollment: Statewide Open Enrollment Act.

Deletes residency requirements and specifically authorizes K-12 students to attend any school in the state. The bill was not heard by this committee due to the shortened 2020 Legislative calendar.

Status: Senate-Died - Education

SB-1423 (Galgiani) – School facilities: charter schools.

Creates financial hardship status for charter schools participating in the state School Facility Program. The bill was subsequently amended to relate to worker classification. Held in Senate Rules.

Status: Senate-Died - Rules

AB-967 (Smith) - Local control and accountability plans.

Requires a charter school to submit its Local Control and Accountability Plan (LCAP) to their charter authorizer for review and approval and requires charter schools to comply with various other LCAP requirements that currently apply to school districts and county offices of education (COE). The bill was vetoed.

Status: Assembly-Vetoed

AB-1127 (Luz Rivas) - Interdistrict attendance: prohibition on transfers by a school district of residence.

Requires a school district of residence to approve an interdistrict transfer request for a victim of an act of bullying, and requires a school district of proposed enrollment that elects to accept an interdistrict transfer to accept all students to apply pursuant to this bill, as specified. Chaptered.

Status: Chapter 781, Statutes of 2019

AB-1505 (O'Donnell) - Charter schools: petitions.

Makes various changes relating to charter school authorizations, appeals, and renewals, clarifies the teacher credentialing requirements of charter schools teachers, and places a two-year moratorium on nonclassroom-based charter schools. Chaptered.

Status: Chapter 486, Statutes of 2019

AB-1507 (Smith) - Charter schools: location: resource center.

Eliminates the authority for a charter school to be located outside the boundaries of their authorizer and allows a nonclassroom-based charter school to establish one resource center within the jurisdiction of the school district where the charter school is located, as specified. Chaptered.

Status: Chapter 487, Statutes of 2019

CONTRACTS K-12

AB-1203 (Bonta) - Local educational agencies: home-to-school transportation: transportation network companies: contracting requirements.

Prohibits a school district, county office of education, or charter school from contracting with a transportation network company for home-to-school transportation unless specified conditions are met. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

EARLY CHILDHOOD EDUCATION/PRESCHOOL/KINDERGARTEN

SB-174 (Leyva) - Early childhood education: reimbursement rates.

Requires, subject to an appropriation; 1) specified subsidized childcare providers be reimbursed based upon an updated regional market rate as of January 1, 2021; 2) establishes the “Quality Counts California Pilot Reimbursement Program,” to provide higher reimbursement rates to Alternative Payment Program childcare providers for meeting certain quality standards and; 3) makes the enactment of this bill contingent upon the enactment of AB 125 of this Session. When heard by this Committee, the bill additionally included the provisions found in AB 125. Held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

SB-321 (Mitchell) - CalWORKs: supportive services: childcare.

Increases access to childcare for welfare-to-work participants by, among other things, requiring that the childcare be full-time, requiring first-stage childcare to be authorized for one year, or until the participant is transferred to the second stage of childcare, and prohibiting the first stage or the second stage of childcare from being discontinued until the family has been enrolled or is ineligible for services in the subsequent stage of childcare. This bill specifies additional activities for which childcare services are available and require that welfare-to-work participants be informed of the availability of childcare services at various times and require specified information sharing between the counties and childcare contractors. Held in Assembly Human Services.

Status: Assembly-Died - Human Services

SB-443 (Rubio) - Transitional kindergarten: average daily attendance.

Deletes the provision that prohibits a school district from generating average daily attendance from a child admitted to transitional kindergarten who has their 5th birthday after December 2 or from being included in the enrollment or unduplicated pupil count until they turn 5 years old thereby expanding eligibility for transitional kindergarten to all four-year-old. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

SB-614 (Rubio) - Early childhood education: county offices of education: grant program.

Establishes, in statute, the Inclusive Early Childhood Education Grant Program for the purpose of increasing access to inclusive early childhood education programs, including children with exceptional needs. The bill was subsequently amended to relate to teacher credentialing. Held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

SB-959 (Hurtado) - Educational equity: immigration and citizenship status.

Requires that the Attorney General expand its model policy developed to assist K-12 schools in responding to immigration issues to include childcare and development programs. The bill additionally, requires that the California Department of Education provide that model policy to childcare programs as well as other information regarding a child's right to be safely enrolled and it requires direct service contract programs to submit documentation to California Department of Education prior to a contract being awarded, renewed or expanded. The bill further modifies existing statute relative to promoting safe learning environments at K-12 schools by defining "pupil," to be inclusive of children enrolled in a childcare and development program administered by a local educational agency. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1075 (Lena Gonzalez) - Transitional kindergarten: admission.

Expands eligibility for transitional kindergarten to students who will have their 5th birthday in July or August, after the current school year ends, thereby expanding eligibility to all four-year-olds. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1153 (Rubio) - Elementary education: kindergarten.

Requires, beginning with the 2021-22 school year, a student to have completed one year of kindergarten before being admitted to the first grade. Therefore, this bill expands compulsory education to include kindergarten. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-6 (Reyes) - Early childhood education: Early Childhood Education Branch.

Requires, by January 1, 2021, the Superintendent of Public Instruction to establish an interagency workgroup that would identify administrative changes to improve the coordination of services provided to children in early learning and care programs and additionally it requires, by January 15, 2021, the establishment of a quality improvement workgroup that would review and propose revisions to the current quality rating and improvement system and program standards, among other things. When heard by this Committee, the bill established the Early Childhood Education Branch with the California Department of Education. The bill was subsequently amended to relate to the Office of the Attorney General. Held in Senate Budget and Fiscal Review.

Status: Senate-Died - Budget and Fiscal Review

AB-123 (McCarty) - Early childhood education: childcare and development programs.

Deems recipients of Medi-Cal or CalFresh as eligible for subsidized child care and authorizes state preschool providers and general child care providers to waive family fees if serving students only via distance learning. This bill also requires the California Department of Education to allow general child care providers to serve children age 0-12 in a commingled classroom. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-125 (McCarty) - Early childhood education: reimbursement rates.

Modifies the state's system and rates for reimbursing subsidized childcare and development programs by creating a more uniform reimbursement system reflecting regional costs of care adjusted for certain factors and subjects the provisions of this bill to the contingent enactment of Senate Bill 174 of the 2019-20 Regular Session. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-197 (Weber) - Full-day kindergarten.

Requires every school within a school district, and every charter school serving pupils in the early primary grades, to implement at least one full-day kindergarten program. The bill was vetoed.

Status: Assembly-Vetoed

AB-324 (Aguiar-Curry) - Childcare services: state subsidized childcare: professional support stipends.

Makes various changes to the staff retention program for providers of subsidized childcare created by AB 212 (Aroner, Chapter 547, Statutes of 2000) by revising the standards related to the professional support stipends. Held in the Senate Appropriations.

Status: Senate-Died - Appropriations

AB-776 (Kalra) - Education data: pupil identifiers: early childhood education programs.

Requires the California Department of Education, in consultation with the California Health and Human Services Agency, no later than January 1, 2021, to establish a process by which early childhood education (ECE) data for children that are enrolled in eligible ECE programs is linked to the California Longitudinal Pupil Achievement System (CALPADS) when the child receives a statewide student identifiers (SSID). This bill authorizes a local educational agency to request an SSID for children enrolled in ECE programs and requires those SSIDS to be submitted to the CALPADS. Vetoed

Status: Assembly-Vetoed

AB-809 (Santiago) - Public postsecondary education: child development programs: priority enrollment: Title IX protection: pregnancy and parental status.

Requires public postsecondary educational institutions notify pregnant or parenting students of protections provided by Title IX. The bill also encourages child development programs established by public postsecondary educational institutions to give priority to children of students who are single parents. Chaptered.

Status: Chapter 265, Statutes of 2019

AB-842 (Limón) - Child nutrition: school, childcare, and preschool meals.

Requires: (1) each part-day California state preschool program (CSPP) to provide at least one nutritious meal per program day; (2) each full-day CSPP to provide to at least two nutritious meals or two snacks and one nutritious meal per program day; and (3) each school district, county office of education, and charter school, that maintains a childcare and development program, to provide at least one nutritionally adequate free or reduced-price meal to each needy child. The bill was vetoed.

Status: Assembly-Vetoed

AB-1001 (Ting) - School bonds: School Disaster Resiliency Act.

Updates the composition and duties of local planning councils (LPCs) and provides that they shall collect local input to facilitate local decision-making regarding early childhood education (ECE) services and also develop and implement a strategic plan and investment priorities. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-2581 (Reyes) - Early childhood development: interagency workgroup.

Establishes an administering entity or entities for early childhood development programs, which shall establish an interagency workgroup that shall include the Director of Early Learning and Care Division at the State Department of Education, the Deputy Superintendent of Public Instruction, and representatives from the State Department of Public Health, the State Department of Health Care Services, the State Department of Developmental Services, and the State Department of Social Services. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-2883 (Quirk-Silva) - Childcare services: alternative payment programs: direct deposits: reserve funds.

Requires that child care providers under the Alternative Payment Program are reimbursed at the full value of the voucher (not just the hours the child attends), and deletes the authorization for providers to adjust rates annually. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

ENGLISH LEARNERS/MIGRANT AND INDIAN EDUCATION

SB-594 (Rubio) - Pupil instruction: English Learner Roadmap Initiative.

Establishes the California English Learner Roadmap Initiative under the administration of California Department of Education, and the California Collaborative for Educational Excellence to build capacity in school districts, county office of education, and charter schools for implementation of the English Learner Roadmap adopted by the State Board of Education to provide guidance on how to serve English learners attending California public schools. When heard by this Committee, it required an appropriation from the General Fund to the California Department of Education for purposes of the bill. Held in the Assembly Education.

Status: Assembly-Died - Education

AB-1319 (Arambula) - Migrant education: pupil residency.

Requires that local educational agencies allow a migrant student to continue their education in the school of origin, regardless of any change of residence during that school year, and requires that a migrant student who is transition between schools, be immediately enrolled in a new school even, if the child is unable to produce records normally required for enrollment. When heard by this committee, the bill did not require information to be provided to parents regarding their child's eligibility for services should they remain in their school of origin. Chaptered.

Status: Chapter 458, Statutes of 2019

FOSTER AND HOMELESS YOUTH

SB-860 (Beall) - Foster Youth Services Coordinating Program: postsecondary education financial aid applications.

Modifies elements of the Foster Youth Services Coordinating Program relative to ensuring program participants complete the Free Application for Federal Student Aid or the California Dream Act Application, and the reporting of information about the completion of those financial aid applications. Chaptered.

Status: Chapter 231, Statutes of 2020

SB-1204 (Jones) - Homeless children and youths: local educational agencies: collaboration.

Requires a local educational agency to collaborate with other organizations that provide specific services to homeless children and youth. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

HEALTH AND NUTRITION

SB-138 (Roth) - Pupil health: type 1 diabetes information: parent notification.

Requires the California Department of Education (CDE) to develop type 1 diabetes informational materials. This bill requires school districts and charter schools to make the type 1 diabetes informational materials accessible to the parents and guardians of pupils on and after January 1, 2021. The bill was held in the Assembly Appropriations Committee.

Status: Assembly-Died - Appropriations

SB-223 (Hill) - Pupil health: administration of medicinal cannabis: schoolsites.

Jojo's Act authorizes the governing board of a school district, a county board of education, or the governing body of a charter school maintaining kindergarten or any of grades 1 to 12, inclusive, to adopt a policy that allows a parent or guardian of a pupil to possess and administer non-smokeable and non-vapeable medicinal cannabis to the authorized pupil at a school site. Chaptered.

Status: Chapter 699, Statutes of 2019

SB-265 (Hertzberg) - Pupil meals: Child Hunger Prevention and Fair Treatment Act of 2017.

Amends the Child Hunger Prevention and Fair Treatment Act of 2017 to require applicable local educational agencies (LEAs) to ensure that a pupil whose parent or guardian has unpaid meal fees is not denied a reimbursable meal of the pupil's choice because of the fact that the pupil's parent or guardian has unpaid meal fees and that the pupil is not shamed or treated differently from other pupils, thus ensuring that all students receive a reimbursable meal. Chaptered.

Status: Chapter 785, Statutes of 2019

SB-328 (Portantino) - Pupil attendance: school start time.

Prohibits middle schools, including those operated as charter school, from beginning their school day before 8:00 a.m., and high schools, including those operated as charter schools, from beginning their school day before 8:30 a.m. When heard by this committee, the bill prohibited middle schools from beginning their school day before 8:30 a.m. Chaptered.

Status: Chapter 868, Statutes of 2019

SB-346 (Jackson) - After school programs: Distinguished After School Health Recognition Program.

Re-establishes the Distinguished After School Health (DASH) Recognition Program, to be administered by the California Department of Education (CDE). The bill was held in the Assembly Appropriations Committee.

Status: Assembly-Died - Appropriations

SB-499 (McGuire) - School meals: California-Grown for Healthy Kids Program.

Establishes the California-Grown for Healthy Kids Program to increase the provision of universally free school meals with California-grown fruits and vegetables, which would include supplemental funds of \$0.10 per breakfast served to eligible school food authorities. The bill was referred to, but not heard in, the Assembly Education Committee.

Status: Assembly-Died - Education

SB-582 (Beall) - Youth mental health and substance use disorder services.

Requires the Mental Health Services Oversight and Accountability Commission to allocate at least one-half of the Investment in Mental Health Wellness Act of 2013 triage grant program funds to local educational agency and mental health partnerships, to support prevention, early intervention, and direct services to children and youth. Held in Assembly Appropriations

Status: Assembly-Died - Appropriations

SB-1281 (Roth) - Pupil health: type 1 diabetes information: parent notification.

Requires the California Department of Education (CDE) to develop type 1 diabetes (T1D) informational materials for the parents and guardians of pupils, and requires school districts, county offices of education, and charter schools to make those informational materials accessible to the parents and guardians of pupils on and after January 1, 2022. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1361 (Glazer) - Pesticides: schoolsites.

Requires the records of all pesticide use at a schoolsite to additionally include licensure or certification information for the individual who applied the pesticide, including, but not limited to, the name of the licensing board or agency that issued the license or certification, but not including that individual's name or the name of their employer, if any. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1369 (Wilk) - Pupil mental health: emergency services.

Establishes the Emergency Program for Pupil Mental Health within the California Department of Education (CDE), which would require the CDE, subject to an appropriation by the Legislature, to establish and operate a grant program to provide funding to local educational agencies to provide mental health services following a qualifying event, either natural or manmade, that is likely to cause sustained and ongoing pupil trauma. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1394 (Morrell) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Amends the California Healthy Youth Act by requiring active parental consent (“opt-in”) with a signature for sexual health and HIV prevention education in grades lower than 7. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1417 (McGuire) - School meals: free or reduced-price meals.

Authorizes local educational agencies, for purposes of the local control funding formula, to establish a base year by carrying over the number of pupils at the school who were eligible for free or reduced-price meals from the school year in which the school applied to use a federal universal school meal provision, and provides, commencing July 1, 2021, that a school district, county superintendent of schools, or charter school that participates in the Community Eligibility Provision at a high poverty school in its jurisdiction, qualifies for a supplemental state reimbursement, as specified. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-8 (Chu) - Pupil health: mental health professionals.

Requires public schools, including charter schools, to have one mental health professional who is accessible on campus during school hours for every 600 pupils by December 31, 2024, and requires counties to provide Mental Health Services Act funding to school districts, county offices of education, and charter schools for that purpose. The bill was held in the Senate Health Committee.

Status: Senate-Died - Health

AB-258 (Jones-Sawyer) - Pupil health: School-Based Pupil Support Services Program Act.

Establishes the School-Based Pupil Support Services Program to increase in-school support services to pupils by appropriating funding from the Youth Education, Prevention, Early Intervention and Treatment Account created by the Control, Regulate and Tax Adult Use of Marijuana Act. The bill was vetoed.

Status: Assembly-Vetoed

AB-354 (Quirk-Silva) - School meals: free or reduced-price meals.

Requires: (1) school districts, county offices of education, and charter schools, that do not participate in a federal school meal programs, to provide adequate space for pupils to consume meals, (2) requires those local educational agencies (LEAs) to report to the California Department of Education (CDE) the alternative meal program each of its schoolsites will follow to ensure that each needy pupil is provided with a free or reduced-price meal, and (3) commencing with the 2021–22 school year, requires CDE to conduct onsite reviews of schoolsites of those LEAs to verify compliance with federal nutrition requirements. The bill was vetoed.

Status: Assembly-Vetoed

AB-479 (Nazarian) - School meals: plant-based food and milk options: California School Plant-Based Food and Beverage Program.

Establishes the California School Plant-Based Food and Beverage Program within the California Department of Education (CDE) in order to: (1) authorize local educational agencies (LEAs) to apply for partial reimbursement for meals that include a plant-based food or milk options, and (2) require CDE to provide competitive grants of up to \$100,000 for specified plant-based food and milk related uses. The bill was held in the Senate Appropriations Committee.

Status: Senate-Died - Appropriations

AB-743 (Eduardo Garcia) - Pupil health: self-administration of prescribed asthma medication.

Requires a school district to accept the written statement from a physician who is contracted with a binational health plan for the purposes of authorizing a pupil to carry and self-administer prescribed inhaled asthma medication that the pupil needs to administer during the regular school day. Chaptered.

Status: Chapter 101, Statutes of 2019

AB-842 (Limón) - Child nutrition: school, childcare, and preschool meals.

Requires: (1) each part-day California state preschool program (CSPP) to provide at least one nutritious meal per program day; (2) each full-day CSPP to provide to at least two nutritious meals or two snacks and one nutritious meal per program day; and (3) each school district, county office of education, and charter school, that maintains a childcare and development program, to provide at least one nutritionally adequate free or reduced-price meal to each needy child. The bill was vetoed.

Status: Assembly-Vetoed

AB-875 (Wicks) - Pupil support services: COVID-19 Support Services and Resiliency for Children Program.

Requires, subject to an appropriation: (1) the SPI to award grants of up to \$500,000.00 to qualifying entities, defined to include schools, local educational agencies, and consortia that meet specified criteria, to pay the costs of planning and operating programs that provide support services related to pupils and their families, as provided. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-1098 (O'Donnell) - Substance use disorders: youth programs.

Requires the Department of Health Care Services (DHCS), in collaboration with the California Department of Education (CDE) and State Department of Public Health (DPH), to convene a technical advisory committee to assist in establishing procedures for the implementation and administration of programs funded by cannabis tax funds aimed at providing substance abuse education and prevention programs targeted toward youth. The bill was an urgency measure and was held in the Senate Appropriations Committee.

Status: Senate-Died - Appropriations

AB-1322 (Berman) - School-based health programs.

Establishes a School-Based Health Unit within the California Department of Education (CDE) to administer and support school-based health programs operated by public schools. The bill was vetoed.

Status: Assembly-Vetoed

AB-1343 (Eggman) - School employees: social workers.

Requires a school district, commencing with the 2022–23 school year, to employ a minimum ratio of one social worker, as defined, for every 250 pupils. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-1767 (Ramos) - Pupil suicide prevention policies.

Requires the governing board or body of a local educational agency that serves kindergarten and grades 1-6 to adopt a policy on student suicide prevention. Chaptered.

Status: Chapter 694, Statutes of 2019

INSTRUCTION AND CURRICULUM

SB-158 (Allen) - Pupil assessment: academic achievement.

Repeals an obsolete code section that required the State Board of Education (SBE) to adopt statewide academically rigorous content standards in the core curriculum areas of reading, writing, and mathematics by January 1, 1998, and in the core curriculum areas

of history/social science and science by November 1, 1998, and to take other related actions. The bill was subsequently amended to relate to the County of Los Angeles Citizens Redistricting Commission. Chaptered.

Status: Chapter 107, Statutes of 2020

SB-673 (Morrell) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Amends the California Healthy Youth Act by: (1) requiring active parental consent (“opt-in”) with a signature for sexual health and HIV prevention education in grades lower than 7, (2) specifically requiring local educational agencies to make written and audio visual materials available for inspection before the date of instruction on the local educational agency’s Internet website, and (3) requiring those material to be translated. The bill failed passage in committee.

Status: Senate-Died - Education

SB-911 (Borgeas) - Public schools: September 11th Remembrance Day.

Designates September 11 of each year as September 11th Remembrance Day, a day having special significance, and encourages each public elementary and secondary school to observe a moment of silence at an appropriate time while school is in session. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1193 (Lena Gonzalez) - Pupil instruction: computer science.

Repeals the sunset dates for the provisions of law that require the Superintendent of Public Instruction (SPI) to convene a computer science strategic implementation advisory panel with a specified membership to develop and submit recommendations for a computer science strategic implementation plan to the SPI, the State Board of Education (SBE), and the Legislature, thereby extending the existence of those provisions indefinitely. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1213 (Leyva) - Pupil instruction: history-social science academic content standards: revisions.

Requires the Superintendent of Public Instruction (SPI), in consultation with the Instructional Quality Commission (IQC) and by November 30, 2023, to recommend to the State Board of Education (SBE) revisions to the history-social science academic content standards, and requires the SBE to adopt, reject, or modify the recommendations by January 31, 2024. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Assembly-Died - Education

SB-1265 (Dahle) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Requires: (1) the required notice to parents and guardians of pupils regarding about a school district's plan to provide sexual health education and HIV prevention instruction to be translated, (2) the written and audiovisual educational materials used in comprehensive sexual health education and HIV prevention education to be translated, and (3) the governing board of a school district shall adopt a policy at a publicly noticed meeting specifying how parents and guardians of pupils may inspect the written and audiovisual educational materials used in comprehensive sexual health education and HIV prevention education. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1394 (Morrell) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Amends the California Healthy Youth Act by requiring active parental consent (“opt-in”) with a signature for sexual health and HIV prevention education in grades lower than 7. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-28 (Oberholte) - High school diplomas: State Seal of STEM.

Establishes the State Seal of Science, Technology, Engineering and Mathematics (STEM) to be voluntarily affixed to the diploma or transcript of a high school graduate who has attained proficiency in science, technology, engineering, and mathematics fields. The bill was vetoed.

Status: Assembly-Vetoed

AB-150 (Cooper) - Pupils: school transfers: coursework for high school graduation.

Requires: (1) that students in foster care and other specified students be issued partial credit for coursework satisfactorily completed when they leave a local educational agency (LEA), (2) that the new LEA contact the prior school to request that those students' full or partial credits be delivered on a transcript, and (3) that partial credit earned in a prior school be accepted as credit in the subject in which the coursework was taken. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-331 (Medina) - Pupil instruction: high school graduation requirements: ethnic studies.

Adds, commencing with the 2024-25 school year, a semester-long course in ethnic studies, based on the ethnic studies model curriculum, to the list of statewide graduation

requirements; and (2) expressly applies all of the statewide graduation requirements to charter schools. The bill was subsequently amended to: (1) commence with the 2029-30 school year; (2) for charter schools, only specifically apply the ethnic studies graduation requirement, not all statewide graduation requirements; and (3) repeal the requirement that ethnic studies courses offered on the basis of the ethnic studies model curriculum be offered as social science or English elective. The bill was vetoed.

Status: Assembly-Vetoed

AB-852 (Burke) - Pupil instruction: academic content standards: update of adopted standards.

Establishes a process for the regular revision of academic content standards prior to the revision of curriculum frameworks. The bill was vetoed.

AB-1051 (Smith) - Community colleges: temporary faculty members: clinical nursing faculty.

Removes the sunset date that provides California Community College districts the ability to exempt part-time community college nursing faculty from the part-time faculty course load cap of 67 percent and thereby, making the exemption from the cap permanent. This bill also, requires colleges and the Community College Chancellor's Office to report annually. Chaptered.

Status: Chapter 234, Statutes of 2019

INSTRUCTIONAL MATERIALS

SB-673 (Morrell) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Amends the California Healthy Youth Act by: (1) requiring active parental consent ("opt-in") with a signature for sexual health and HIV prevention education in grades lower than 7, (2) specifically requiring local educational agencies to make written and audio visual materials available for inspection before the date of instruction on the local educational agency's Internet website, and (3) requiring those material to be translated. The bill failed passage in committee.

Status: Senate-Died - Education

SB-1265 (Dahle) - Comprehensive sexual health education and human immunodeficiency virus (HIV) prevention education.

Requires: (1) the required notice to parents and guardians of pupils regarding about a school district's plan to provide sexual health education and HIV prevention instruction to be translated, (2) the written and audiovisual educational materials used in comprehensive sexual health education and HIV prevention education to be translated, and (3) the governing board of a school district shall adopt a policy at a publicly noticed

meeting specifying how parents and guardians of pupils may inspect the written and audiovisual educational materials used in comprehensive sexual health education and HIV prevention education. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

K-12 AND HIGHER EDUCATION FACILITIES

SB-14 (Glazer) - Education finance: Higher Education Facilities Bond Act of 2020.

Places an \$8 billion general obligation bond on the March 2020 ballot for the construction, reconstruction, and remodeling of existing or new facilities at the University of California (UC), the California State University (CSU), and the Hastings College of the Law. Held in Assembly Rules.

Status: Assembly-Died - Rules

SB-56 (Roth) - University of California, Riverside School of Medicine: expansion.

Authorizes the construction of a new University of California, Riverside School of Medicine facility, subject to appropriation. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-297 (Pan) - School facilities: approval of plans.

Allows school and community college districts to award construction contracts, but not perform any construction, prior to receiving plan approval from the State Architect. Held in Assembly Education.

Status: Assembly-Died - Education

SB-743 (Hertzberg) - School facilities: design-build projects.

Clarifies that, upon entering into a design-build contract for a project subject to the California Environmental Quality Act (CEQA), Los Angeles Unified School District shall retain the discretion to terminate the contract before final project design submittal and modify the project as needed to ensure project compliance with CEQA. Chaptered.

Status: Chapter 275, Statutes of 2019

SB-1017 (Portantino) - School facilities: proceeds from sale or lease of surplus property: affordable rental housing facilities.

Limits which school districts are exempt from existing laws related to the sale, lease, or exchange of school property to districts that plan to provide affordable rental housing for their employees and provides these districts with additional flexibility in how their sale or

lease proceeds can be used. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1355 (Durazo) - California Community Colleges: affordable housing.

Expands the ways in which a community college districts can enter a joint occupancy agreement with a private person, firm, or corporation to provide its students and employees with affordable housing developments. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-48 (O'Donnell) - Education finance: school facilities: Public Preschool, K-12, and College Health and Safety Bond Act of 2020.

Makes changes to the existing School Facility Program and places the Public Preschool, K-12, and College Health and Safety Bond Act on the March 3, 2020 primary ballot. Chaptered.

Status: Chapter 530, Statutes of 2019

AB-356 (Santiago) - Los Angeles Community College District: best value procurement: pilot program.

Provides for a five-year pilot program for the Los Angeles Community College District to use best value procurement for projects over \$1 million. Chaptered.

Status: Chapter 173, Statutes of 2019

AB-452 (Mullin) - Childcare: facilities: grants.

Establishes the "California Childcare Facilities Grant Fund" (CCFGF) to replace the Child Care Facilities Revolving Fund (CCFRF) and to supply grants to providers of publicly-funded child care for the improvement or construction of facilities to house programs for infants and toddlers. Senate Education, not heard.

Status: Senate-Died - Education

AB-695 (Medina) - Community college facilities: design-build contracts.

Extends the authority for community college districts to enter into design-build public works contracts. Chaptered.

Status: Chapter 492, Statutes of 2019

AB-1303 (O'Donnell) - School facilities: Civic Center Act: direct costs.

Extends the sunset date by five years on the authority for school districts to charge an entity a fee for the use of the school's facilities or grounds that includes the costs for a proportion of the operating and maintenance costs. Chaptered.

Status: Chapter 541, Statutes of 2019

AB-1578 (Luz Rivas) - School Pavement to Parks Grant Program.

Establishes the School Pavement to Parks Grant Program to assist schools located in disadvantaged communities to convert existing pavement to green space. The bill was vetoed.

Status: Assembly-Vetoed

AB-1981 (Nazarian) - Los Angeles Unified School District: best value procurement.

Extends the authority for the Los Angeles Unified School District (LAUSD) to use the best value procurement method by five years, from January 1, 2021, to January 1, 2026. Chaptered.

Status: Chapter 46, Statutes of 2020

OTHER LEGISLATION K12

SB-328 (Portantino) - Pupil attendance: school start time.

Prohibits middle schools, including those operated as charter school, from beginning their school day before 8:00 a.m., and high schools, including those operated as charter schools, from beginning their school day before 8:30 a.m. When heard by this committee, the bill prohibited middle schools from beginning their school day before 8:30 a.m. Chaptered.

Status: Chapter 868, Statutes of 2019

SB-686 (Allen) - California Promise Neighborhoods Act of 2019.

Establishes, contingent upon an appropriation, the California Promise Neighborhood Grant Program, to be administered by the California Department of Education (CDE), for the purpose of awarding up to 20 grants of up to \$5 million each, on a competitive basis, to eligible entities to implement a comprehensive, integrated continuum of cradle-to-college-to-career solutions, including academic, health, and social programs, and family and community supports. The bill was held in the Assembly Appropriations Committee.

Status: Assembly-Died - Appropriations

SB-911 (Borgeas) - Public schools: September 11th Remembrance Day.

Designates September 11 of each year as September 11th Remembrance Day, a day having special significance, and encourages each public elementary and secondary school to observe a moment of silence at an appropriate time while school is in session. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1025 (Umberg) - Libraries: student success cards.

Requires schools to enter into a memorandum of agreement with a local library district or public library to provide each student with a student success card (library card). The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1181 (Committee on Education) - Elementary and secondary education: omnibus bill.

The annual K-12 education policy omnibus bill, makes technical, clarifying, conforming, and other non-controversial revisions to a number of provisions in the Education Code. The bill was not heard by the Assembly Education Committee due to the shortened 2020 Legislative Calendar.

Status: Assembly-Died - Education

SB-1193 (Lena Gonzalez) - Pupil instruction: computer science.

Repeals the sunset dates for the provisions of law that require the Superintendent of Public Instruction (SPI) to convene a computer science strategic implementation advisory panel with a specified membership to develop and submit recommendations for a computer science strategic implementation plan to the SPI, the State Board of Education (SBE), and the Legislature, thereby extending the existence of those provisions indefinitely. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1308 (Leyva) - Educational equity: government instruction conferences: Sacramento.

Prohibits public funds or resources from being used in connection with any secondary educational program of government instruction located in Sacramento that does not provide an equal opportunity for female and male students. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SCR-6 (Nielsen) - Celebrate Freedom Week.

Calls upon public schools with grades K-12, inclusive, to recognize the week of September 15, 2019, to September 21, 2019, as Celebrate Freedom Week, a week that celebrates the origin of the United States government. Held in Assembly Appropriations

Status: Assembly-Died - Appropriations

AB-150 (Cooper) - Pupils: school transfers: coursework for high school graduation.

Requires: (1) that students in foster care and other specified students be issued partial credit for coursework satisfactorily completed when they leave a local educational

agency (LEA), (2) that the new LEA contact the prior school to request that those students' full or partial credits be delivered on a transcript, and (3) that partial credit earned in a prior school be accepted as credit in the subject in which the coursework was taken. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-413 (Jones-Sawyer) - Education: at-promise youth.

Changes the term "at-risk" to "at-promise" in various sections of the Education Code and Penal Code. Chaptered.

Status: Chapter 800, Statutes of 2019

AB-711 (Chiu) - Pupil records: name and gender changes.

Requires local educational agencies (LEAs) to update and reissue the school records of a former pupil in order to reflect the former pupil's updated and correct legal name and/or gender if the LEA receives government-issued documentation that the former pupil's legal name and/or gender has been changed. Chaptered.

Status: Chapter 179, Statutes of 2019

AB-773 (Gonzalez) - Voter education: high school pupils.

Establishes that the months of January and September shall be recognized as "Voter Education Months" and requires the Secretary of the State, in coordination with the Superintendent of Public Instruction, to develop voter educational programming for local educational agencies to implement as a presentation to pupils in grade 12 at the school site. The bill was vetoed

Status: Assembly-Vetoed

AB-875 (Wicks) - Pupil support services: COVID-19 Support Services and Resiliency for Children Program.

Requires, subject to an appropriation: (1) the SPI to award grants of up to \$500,000.00 to qualifying entities, defined to include schools, local educational agencies, and consortia that meet specified criteria, to pay the costs of planning and operating programs that provide support services related to pupils and their families, as provided.

Status: Senate-Died - Education

AB-901 (Gipson) - Juveniles.

Limits the authority of a probation department to supervise and provide services to minors who are within the jurisdiction of the juvenile courts and eliminates the provision of law that makes a minor who persistently or habitually refuses to obey the reasonable and proper orders or directions of school authorities within the jurisdiction of the juvenile court. Chaptered.

Status: Chapter 323, Statutes of 2020

AB-908 (O'Donnell) - Pupils: extracurricular activities: work permits.

(1) Authorizes a school district to extend its probationary period for pupils to demonstrate satisfactory progress, for purposes of extracurricular and cocurricular activities, through the conclusion of the 2020-21 school year; (2) authorizes documentation required for purposes of pupil work permits to be submitted electronically during an extended school closure due to a natural disaster, pandemic, or other emergency; and (3) prohibits a work permit from being denied based on a pupil's grades, grade point average, or school attendance when the pupil's school has been physically closed for an extended time due to natural disaster, pandemic, or other emergency. The bill was an urgency measure. Chaptered.

Status: Chapter 64, Statutes of 2020

AB-1036 (Aguilar-Curry) - Elections: civic outreach and voter engagement.

Authorizes the Yolo County Elections Office, in partnership with the Yolo County Office of Education, to conduct a mock election pilot program to elect members of the school's student government, as specified. This bill also updates existing statutes requiring the Secretary of State (SOS) to maintain voter registration at the highest possible level, as specified, and expands the list of specified purposes for which the SOS is permitted to provide grants to local elections officials, nonprofit corporations, and unincorporated associations. The bill was vetoed

Status: Assembly-Vetoed

AB-1062 (Limón) - Pupil instruction: community emergency response training.

Authorizes the governing board of a school district, if it requires the completion of community service hours as a high school graduation requirement from high school, to provide a pupil with credit towards the community service hours required for graduation commensurate with the hours required for completion of a course in community emergency response training. Chaptered.

Status: Chapter 70, Statutes of 2019

AB-1595 (Committee on Education) - Elementary and secondary education: omnibus bill.

The annual K-12 education policy omnibus bill, makes technical, clarifying, conforming, and other non-controversial revisions to a number of provisions in the Education Code. Chaptered.

Status: Chapter 543, Statutes of 2019

AB-1666 (Reyes) - The California Complete Count: local educational agencies.

Requires the California Complete Count – Census 2020 to partner with local educational agencies to make information about the 2020 federal census available to students and parents. The bill was an urgency measure. Chaptered.

Status: Chapter 560, Statutes of 2019

AB-2126 (O'Donnell) - Temporary school closures: notification: survey.

Requires the California Department of Education (CDE) to develop and implement a website, app, and survey to collect temporary school closure information from local educational agencies (LEAs), including whether an LEA has a plan to provide meals and instruction during school closures lasting longer than five school days. The bill was held in the Senate Appropriations Committee.

Status: Senate-Died - Appropriations

ACR-87 (Quirk-Silva) - Upholding democracy through civic education in public schools.

Encourages schools to pursue recognized designations that reflect the ethos and values described in this resolution, such as California Democracy School Civic Learning Initiatives, the California State Seal of Civic Engagement, and the California Civic Learning Awards. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SAFE SCHOOLS AND PUPIL PROTECTION

SB-86 (Portantino) - School safety: lockdown drills.

Requires comprehensive school safety plans. Commencing with the 2020–21 school year, to include procedures requiring either, at the discretion of the school district or county office of education, a lockdown drill or a multioption response drill, to be conducted in an age-appropriate manner at least once per school year at each school. The bill was subsequently amended to relate to pesticide regulation.

Status: Chapter 299, Statutes of 2020

SB-316 (Rubio) - Pupil safety: identification cards: domestic violence hotline telephone numbers.

Requires public schools, including charter schools, commencing October 1, 2020, that serve pupils in any of grades 9 to 12, inclusive, and that issue pupil or student identification cards, to print the telephone number for the National Domestic Violence Hotline on the back of those identification cards; and requires public or private institutions of higher education, that issue pupil or student identification cards, to print the

telephone number for the National Domestic Violence Hotline or a local domestic violence hotline that provides confidential support services for students that have experienced domestic violence. When heard by this committee, the bill's commencing date was July 1, 2020. Chaptered.

Status: Chapter 270, Statutes of 2019

SB-371 (Caballero) - Schoolbuses: stop requirements.

Authorizes school districts to install automated school bus video enforcement system for school bus passing violations. The bill was not taken up on the Senate floor.

Status: Senate-Died

SB-541 (Bates) - School safety: lockdown drills.

Requires the California Department of Education (CDE) to collect, and local educational agencies (LEAs) to provide, data pertaining to lockdown or multioption response drills conducted at schoolsites within school districts, county offices of education and charter schools providing instructional services to pupils in kindergarten or in any of grades 1 to 12, inclusive, and requires the CDE to submit a report to the Legislature relative to that data. When the bill was heard in this committee, it required every public and private school that provides educational services to pupils in kindergarten or in any of grades 1 to 12, inclusive, with an enrollment of 50 or more pupils or more than one classroom, to conduct a lockdown drill at least once per school year. Chaptered.

Status: Chapter 786, Statutes of 2019

SB-709 (Morrell) - School employment: Sexual Abuse-Free Education (SAFE) Act.

Establishes the Sexual Abuse-Free Education Act to: (1) prohibit public and private school entities from hiring individuals that would have direct contact with children if they were previously convicted of child abuse or sexual misconduct with a child, (2) require applicants for school entity positions that would have direct contact with children to provide specified information about whether the applicant has ever been the subject of an investigation concerning child abuse or sexual misconduct with a child, and (3) require school entities to conduct reviews of the information provided by the applicants, including obtaining specified information from the current and each former employer. Senate Education, not heard.

Status: Senate-Died - Education

SB-959 (Hurtado) - Educational equity: immigration and citizenship status.

Requires that the Attorney General expand its model policy developed to assist K-12 schools in responding to immigration issues to include childcare and development programs. The bill additionally, requires that the California Department of Education provide that model policy to childcare programs as well as other information regarding a child's right to be safely enrolled and it requires direct service contract programs to

submit documentation to California Department of Education prior to a contract being awarded, renewed or expanded. The bill further modifies existing statute relative to promoting safe learning environments at K-12 schools by defining “pupil,” to be inclusive of children enrolled in a childcare and development program administered by a local educational agency. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1005 (Morrell) - Local educational agencies: confidentiality agreements: child predators.

Prohibits a local educational agency from entering or renewing a confidentiality agreement with or providing an employment recommendation for a child predator. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1091 (Portantino) - School safety: mandatory interagency cross-reporting.

Requires the School/Law Enforcement Partnership to develop a process and framework that would require mandatory interagency cross-reporting between school districts, county offices of education, and law enforcement agencies of threats of serious school crimes, including, but not necessarily limited to, school shootings, hate crimes, vandalism, drug and alcohol use, gang membership, and gang violence, that would trigger immediate intervention. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1269 (Allen) - School safety: bias-related discrimination, harassment, intimidation, and bullying: model handout.

Requires the California Department of Education to periodically review and update the model handout describing specified rights of pupils and obligations relating to educational equity and the policies addressing bias-related discrimination, harassment, intimidation, and bullying in schools, to ensure the availability of relevant and recent information. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1361 (Glazer) - Pesticides: schoolsites.

Requires the records of all pesticide use at a schoolsite to additionally include licensure or certification information for the individual who applied the pesticide, including, but not limited to, the name of the licensing board or agency that issued the license or certification, but not including that individual’s name or the name of their employer, if any. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-34 (Ramos) - Pupils: bullying and harassment prevention information.

Requires local educational agencies (LEAs), commencing with the 2020-21 school year, to provide specified bullying and harassment prevention information in a prominent location on their existing Internet Web site. Chaptered.

Status: Chapter 282, Statutes of 2019

AB-216 (Weber) - School safety: Pupil and Staff Safety Pilot Program.

Establishes the Pupil and Staff Safety Pilot Program, to be administered by the Scale Up MTSS Statewide (SUMS) project, for the purpose of training school staff de-escalation techniques and alternatives to physical restraint and seclusion of students. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-272 (Muratsuchi) - Pupils: use of smartphones.

Provides that a student shall not be prohibited from possessing or using a smartphone under specified circumstances, and authorizes governing bodies to adopt a policy to limit or prohibit the use of smartphones by students while at school. Chaptered.

Status: Chapter 42, Statutes of 2019

AB-276 (Friedman) - Pupil safety: parental notification: firearm safety laws.

Requires schools to inform parents and guardians of California's child access prevention and other laws relating to the safe storage of firearms. The bill was not heard by this committee due to shortened 2020 Legislative Calendar and was subsequently amended to relate to personal income taxes.

Status: Chapter 62, Statutes of 2020

AB-543 (Smith) - Education: sexual harassment: written policy: posters.

Requires public schools serving grades 9-12 to create and prominently display a poster that notifies its pupils of their sexual harassment policy. This bill extends the existing requirement for educational institutions to provide a written copy of its sexual harassment policy to require that continuing pupils also receive this information (in addition to new students). Chapter 428, Statutes of 2019

Status: Chapter 428, Statutes of 2019

AB-624 (Gabriel) - Pupil and student health: identification cards: sexual assault and domestic violence hotline telephone numbers.

Requires public and private schools that serve grades 7-12, and public and private institutions of higher education, that issue student identification cards to print on either side of the cards the telephone numbers for the National Sexual Assault Hotline, and the National Domestic Violence Hotline. The bill was vetoed.

Status: Assembly-Vetoed

AB-1767 (Ramos) - Pupil suicide prevention policies.

Requires the governing board or body of a local educational agency that serves kindergarten and grades 1-6 to adopt a policy on student suicide prevention. Chaptered.

Status: Chapter 694, Statutes of 2019

AB-1837 (Smith) - School safety: emergency response team.

Requires the Superintendent of Public Instruction (SPI) to establish a State Assistance for Emergency Response (SAFER) Team within the California Department of Education (CDE) to provide guidance and support to local educational agencies (LEAs) experiencing emergencies. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died – Education

SCHOOL AND DISTRICT GOVERNANCE

SB-585 (Wieckowski) - Education governance: school district reorganization: unified school districts: report.

Requires the California Department of Education to prepare a plan for a transition so that, as of July 1, 2025, all school districts will be unified school districts if the plan were enacted into law. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-709 (Bonta) - School districts: governing boards: pupil members.

Authorizes the governing board of a school district to award a student member elective course credit for serving on the board, and prohibits student members from being considered members of the governing board for purposes of the Ralph M. Brown Act. Chaptered.

Status: Chapter 437, Statutes of 2019

SCHOOL FINANCE AND LOCAL CONTROL FUNDING FORMULA

SB-675 (Chang) - Education finance: Computer Occupations and Developing Education (CODE) Act: State Lottery Fund.

Establishes the Computer Occupations and Developing Education (CODE) Act, a grant program for local educational agencies offering computer science courses funded with up to \$100 million of State Lottery Funds. Held in Senate Governmental Organization

Status: Senate-Died - Governmental Organization

SB-729 (Portantino) - Local control funding formula: school districts and charter schools.

Dedicates additional funding to the Local Control Funding Formula (LCFF) by increasing the applicable cost-of-living adjustment for the LCFF in 2019-20. The bill was subsequently amended to relate to meal and rest breaks for remote workers. Held in Assembly Labor and Employment.

Status: Assembly-Died - Labor and Employment

SB-884 (Dodd) - Education finance: emergencies: public safety power shutoffs.

Adds public safety power shutoffs to the list of emergencies that a local educational agency's (LEA) average daily attendance (ADA) is held harmless for. Held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

SB-1214 (Portantino) - School accountability: local control funding formula: expenditures.

Requires the State Board of Education (SBE) to update the regulations that govern the expenditure of Local Control Funding Formula (LCFF) supplemental and concentration grant funds by March 31, 2021, as specified. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-39 (Muratsuchi) - Education finance: local control funding formula: aspirational funding level: reports.

Expresses the intent of the Legislature to increase the per-student base grant funding targets for school districts and charter schools under the Local Control Funding Formula (LCFF). Senate Floor, inactive file.

Status: Senate-Died

AB-1835 (Weber) - Education finance: local control funding formula: supplemental and concentration grants.

Requires each local educational agency (LEA) to annually identify and report unspent Local Control Funding Formula (LCFF) supplemental and concentration grant funds and clarifies that the unspent funds must continue be used to increase or improve services for unduplicated pupils in future years. The bill was vetoed.

Status: Assembly-Vetoed

SPECIAL EDUCATION

SB-217 (Portantino) - Special education: individuals with exceptional needs.

Creates the Early Intervention Grant Program to increase access to early education programs for children with exceptional needs and expands eligibility for transitional kindergarten to include children with exceptional needs turning five years old at any time during the school year. The bill was subsequently amended to relate to recreational and organizational camps. Held in Assembly Health.

Status: Assembly-Died - Health

SB-695 (Portantino) - Special education: individualized education programs: translation services.

Requires a local educational agency (LEA), upon a parent's request, to translate the student's individualized education program (IEP) and other related documents in the native language of the parent within 30 calendar days of the IEP team meeting. The bill was vetoed.

Status: Senate-Vetoed

SB-1063 (Durazo) - Developmental services: competitive integrated employment.

Establishes a new definition of "competitive integrated employment" and conforms the required contents of an individualized education program (IEP) to include information on how the local educational agency (LEA) will support students in obtaining or retaining competitive integrated employment. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1174 (Portantino) - Special education: dyslexia testing.

Requires local educational agencies (LEAs) serving students in kindergarten to grade 2 to screen all students for dyslexia using a new state-approved assessment, unless objected to in writing by a student's parent or guardian. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SJR-8 (Wilk) - Special education funding.

Memorializes the Congress and the President of the United States to enact H.R. 2902 to fully fund the federal Individuals with Disabilities Education Act (IDEA). Chaptered.

Status: Chapter 131, Statutes of 2019

AB-236 (Eduardo Garcia) - Special education programs: Family Empowerment Centers on Disability.

Requires the California Department of Education (CDE) to give priority to applicants for grants to Family Empowerment Centers on Disability (FEC) in regions of the state that do not have a FEC, provides a cost-of-living adjustment, and increases base funding once there is a Family Empowerment Center in each of the 32 regions in the state. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-428 (Medina) - Special education funding.

Requires that special education funding rates to be equalized to the 95th percentile after the Local Control Funding Formula (LCFF) is fully funded and makes other various special education funding changes. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-605 (Maienschein) - Special education: assistive technology devices.

Requires, consistent with federal regulations, that local education agencies (LEAs) allow students the use of school-purchased assistive technology devices at the student's home or in other settings if a student's individualized education plan (IEP) team determines that the student needs access to those devices in order to receive a free and appropriate public education. Chaptered.

Status: Chapter 228, Statutes of 2019

AB-947 (Quirk-Silva) - Visually impaired pupils: expanded core curriculum.

Establishes an expanded core curriculum for students who are blind, have low vision, or are visually impaired and authorizes local educational agencies (LEAs) to consider the expanded core curriculum when developing students' individualized education programs. Chaptered.

Status: Chapter 778, Statutes of 2019

AB-1172 (Frazier) - Special education: nonpublic, nonsectarian schools or agencies.

Places new documentation requirements on nonpublic schools (NPS) related to their administrators and staff trainings, places new monitoring requirements on local educational agencies (LEAs) that enter into contract with an NPS, and places notification requirement on an NPS for any pupil-involved incident involving law enforcement. Chaptered.

Status: Chapter 454, Statutes of 2019

AB-1354 (Gipson) - Juvenile court school pupils: joint transition planning policy: individualized transition plan.

Requires county offices of education (COEs) to ensure that a student enrolled in a juvenile court school for more than 20 school days has an individualized transition plan and access to specified educational records upon release. Chaptered.

Status: Chapter 756, Statutes of 2019

AB-3097 (Frazier) - Special education: nonpublic, nonsectarian schools or agencies.

Implements technical cleanup for local educational agencies (LEAs) monitoring and reporting on students with disabilities attending nonpublic, nonsectarian schools. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

STAFFING AND ADMINISTRATION/COLLECTIVE BARGAINING

SB-390 (Umberg) - School districts and community college districts: school security officers and security guards.

Requires all security guards working on school and community college campuses to complete the latest training developed by the Department of Consumer Affairs and specifies that local educational agencies must provide the training to all security guards during their regular work hours. Chaptered.

Status: Chapter 475, Statutes of 2019

SB-428 (Pan) - Teachers: youth mental health first aid.

Requires the California Department of Education (CDE) to identify an evidence-based training program for local educational agencies to use to train classified and certificated school employees having direct contact with pupils in youth mental and behavioral health. The bill was vetoed.

Status: Senate-Vetoed

SB-796 (Leyva) - School and community college employees: absences due to illness or accident.

Requires certificated and classified school and community college employees who have exhausted all sick leave to continue to receive their full pay while out on extended leave due to illness or injury. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-805 (Portantino) - School employees: leaves of absence: natural disasters and evacuation orders.

Prohibits school districts from requiring employees to use their paid leave if they are unable to report to work because the school is forced to close as a result of a natural disaster or an evacuation order. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-500 (Gonzalez) - School and community college employees: paid maternity leave.

Requires that school districts, charter schools, and community colleges provide at least six weeks of full pay for pregnancy-related leaves of absence taken by certificated, academic, and classified employees. The bill was vetoed.

Status: Assembly-Vetoed

AB-1859 (Santiago) - School district employees: merit system: appointments.

Extends the authority for the Los Angeles Unified School District (LAUSD) to fill a classified vacancy with an applicant who is not among the first three ranks of an eligibility list, as specified, until January 1, 2027. Chaptered.

Status: Chapter 67, Statutes of 2020

SUSPENSIONS AND EXPULSIONS

SB-419 (Skinner) - Pupil discipline: suspensions: willful defiance.

Extends, commencing July 1, 2020, the prohibition against suspending a pupil enrolled in kindergarten or any of grades 1 to 3 for disrupting school activities or otherwise willfully defied the valid authority of school staff to include grades 4 and 5 permanently; and to include grades 6 to 8, inclusive, until July 1, 2025; and applies these prohibitions to charter schools. When the bill was heard in this committee, it extended the prohibition to include grades 4 to 8 permanently, and grades 9 to 12 until January 1, 2025. Chaptered.

Status: Chapter 279, Statutes of 2019

SB-702 (Hill) - Pupil and student discipline: antihazing policies and definitions: reporting of violations.

Specifies, for purposes of suspensions and expulsions for hazing, that a person engages or attempts to engage in hazing if that person engages in hazing directly, solicits, encourages, directs, aids, or attempts to aid another person in engaging in hazing, recklessly permits hazing to occur, or has firsthand knowledge of the planning of a specific hazing incident involving a pupil in an educational institution, or has firsthand knowledge that a specific hazing incident has occurred, and knowingly fails to report that knowledge in writing to the dean of pupils or other appropriate official of the educational

institution. Before being heard in this committee, the bill was amended to relate to the California Renewables Portfolio Standard Program. Chaptered.

Status: Chapter 305, Statutes of 2020

AB-982 (Holden) - Pupils: homework assignments for suspended pupils.

Requires a teacher, upon the request of a parent, a legal guardian or other person holding the right to make educational decisions for a pupil, or the affected pupil, to provide homework to the pupil who has been suspended for two or more schooldays, and requires a charter school petition to include procedures to require the same. Chaptered.

Status: Chapter 779, Statutes of 2019

TECHNOLOGY/DATA K-12

AB-398 (Chu) - School accountability: local control and accountability plans: visual and performing arts.

Authorizes a school district to submit enrollment and completion data specifically related to visual and performing arts courses through the California Longitudinal Pupil Achievement Data System (CALPADS), using existing state courses codes for students in first through sixth grades. The bill was not heard by this committee due to shortened 2020 Legislative Calendar and was subsequently amended to relate to COVID-19 and local government finance.

Status: Senate-Died - Governance and Finance

AB-2626 (Bauer-Kahan) - Digital divide: distance learning: California Research Bureau: communications technology grant program.

Establishes the Bridging the Digital Divide Grant Program to be administered by California Department of Education. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

THE TEACHING PROFESSION

SB-478 (Rubio) - Commission on Teacher Credentialing: membership.

Changes the membership of the Commission on Teacher Credentialing (CTC) by replacing one public member with a certificated public school human resource administrator. Chaptered.

Status: Chapter 148, Statutes of 2019

AB-525 (Luz Rivas) - Teacher credentialing.

Allows individuals seeking a special education or pupil personnel services teaching credential to hold a baccalaureate degree in education and makes other technical changes related to teacher credentialing. Chaptered.

Status: Chapter 427, Statutes of 2019

AB-988 (Berman) - Teacher credentialing: out-of-state prepared teachers: education specialist credential.

Allows an out-of-state prepared candidate for the education specialist credential to demonstrate their area of concentration based on two years of experience in California, while the candidate holds a Preliminary credential. Chaptered.

Status: Chapter 103, Statutes of 2019

AB-1219 (Jones-Sawyer) - Teacher credentialing: certificated employee assignment monitoring.

Requires the Commission on Teacher Credentialing (CTC) to develop and implement a statewide automated State Assignment Accountability System (CalSAAS) for annual monitoring of teacher misassignments in schools, including charter schools, and revises local responsibilities for the monitoring of teacher misassignments. Chaptered.

Status: Chapter 782, Statutes of 2019

AB-1410 (Quirk-Silva) - Teachers: Computer Science Access Initiative.

Establishes the Computer Science Access Initiative with the goal of increasing the number of teachers who are authorized and trained to provide computer science instruction. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-1623 (Robert Rivas) - Teaching credential: teacher recruitment: Golden State Teacher Grant Program.

Establishes the Golden State Teacher Grant Program under administration of the California Student Aid Commission (CSAC) to provide one-time grant funds of \$20,000 to each student enrolled on or after January 1, 2020, in a professional preparation program leading to a preliminary teaching credential, if the student commits to working in a high-need subject area field for four years after they receive a teaching credential. Senate Education, not heard.

Status: Senate-Died - Education

AB-1658 (Carrillo) - Teacher credentialing: adult education: workgroup.

Requires the Commission on Teacher Credentialing (CTC) to establish a workgroup to study issues relating to adult education teacher credentialing. The bill was vetoed.

Status: Assembly-Vetoed

AB-1982 (Cunningham) - Teacher credentialing: basic skills proficiency test: exemption.

Authorizes, until December 31, 2023, a teacher credential applicant to demonstrate basic reading, writing, and math skills through coursework instead of by passing the California Basic Educational Skills Test (CBEST). The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-2485 (Kalra) - Teacher credentialing: subject matter competence.

Authorizes, until December 31, 2023, a teaching credential candidate to demonstrate subject matter competence through coursework instead of passing the California Subject Examinations for Teachers (CSET). The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-2541 (Medina) - Teacher preparation programs: regionally accredited institutions.

Expands who is eligible to apply for a teaching credential program by including graduates from a higher education institution that is not yet accredited, but is in preaccreditation status and earns accreditation within five years. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

HIGHER EDUCATION

ACCESS/SUCCESS

SB-148 (Glazer) - Public postsecondary education: the California Promise: Student Success and On-time Completion Fund.

Creates the Student Success and On-time Completion Fund in the State Treasury, and authorizes the California State University Trustees to use money in that fund to incentivize student participation in a California Promise program by offering grants to students for timely progress towards college completion and participation in a summer term. It also requires the California State University to waive systemwide tuition or fees for a participating student unable to complete their degree due to limited space or lack of course offerings. The bill limits participation in the California Promise program to lower-income students for any student not already participating as of the 2020-21 academic year. The bill was held in Assembly Higher Education.

Status: Assembly-Died - Appropriations

SB-484 (Portantino) - Public postsecondary education: community college transfer students.

Requires the governing board of each community college district to direct colleges to identify, notify and automatically award degrees to students who have completed the requirements for an associate degree for transfer. The bill also requires that the student be added to an identification system that is maintained by the California Community Colleges, Chancellor's Office in a manner that is accessible to the California State University, the University of California and independent institutions of higher education as defined for purposes of streamlining transfer. When heard by this Committee, the bill limited access to the California Community College student identification system to public universities, the bill was subsequently amended to extend access to certain non-public independent institutions of higher education. The bill was vetoed.

Status: Senate-Vetoed

SB-1211 (Glazer) - Public postsecondary education: California Promise program: California State University students.

Expands, commencing with the 2021-22 academic year, the number of California State University campuses required to establish a California Promise program and sets a threshold for the number of students required in the program from the incoming class. The bill exempts a participating campus from any requirement to increase its level of participation in the program if it achieves the specified 4-year graduation rate goals. Additionally, it requires that 70 percent of participants from the incoming class being either low-income students, first-generation students, or students from communities that are underrepresented in postsecondary education. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar

Status: Senate-Died - Education

AB-2 (Santiago) - Community colleges: California College Promise.

Modifies the California College Promise fee waiver, relative to California Community Colleges, to authorize a student who is in the disabled student services program and is enrolled in fewer than 12 units to be deemed "fulltime," and to include a reporting requirement. Chaptered.

Status: Chapter 509, Statutes of 2019

AB-595 (Medina) - Community colleges: apprenticeship programs.

Authorizes the use of an individual tax identification number for purposes of conducting background checks required by class or program for a student enrolled in a community college apprenticeship or internship training program who does not have a social security number. Chaptered.

Status: Chapter 176, Statutes of 2019

AB-1645 (Blanca Rubio) - Student support services: Dreamer Resource Liaisons.

Requires the California Community Colleges and the California State University, and requests the University of California, to designate a Dreamer Resource Liaison who is knowledgeable in financial aid and other support services to assist students who qualify for the exemption from paying nonresident tuition established by AB 540 (Firebaugh, Chapter 814, Statutes of 2001). It also encourages the establishment of Dream Resource Centers on each campus. Chaptered.

Status: Chapter 788, Statutes of 2019

AB-2341 (McCarty) - Student Equity and Achievement Program: Rising Scholars Network: justice-involved students.

Authorizes the Office of the Chancellor of the California Community Colleges to establish a program, named the Rising Scholars Network, as part of the Student Equity and Achievement Program, to enter into agreements with up to 50 community colleges to provide additional funds for services in support of postsecondary education for justice-involved students. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-2972 (Limón) - Public postsecondary education: undocumented students.

Requires the California Community Colleges Board of Governors and the California State University Trustees, and encourages the University of California Regents, to create a systemwide training program, for administrators, faculty, and staff, of those respective segments to complete annually, relating to undocumented students, Deferred Action for Childhood Arrivals, federal and state laws related to immigration generally state law relating to exemption from nonresident tuition, and resources that the system or campus has for undocumented students. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar

Status: Senate-Died - Education

ACCOUNTABILITY

AB-697 (Ting) - Student financial aid: Cal Grant Program: qualifying institutions.

Requires, by June 30 of each year from 2021 to 2024, the California State University, Board of Trustees, the University of California, Board of Regents, and the appropriate governing bodies of each independent institution of higher education that is a qualifying institution, as defined under the Cal Grant program, that provides preferential treatment

in admissions to applicants with a relationship to donors or alumni, to annually report information about those admissions to the Legislature. Chaptered.

Status: Chapter 514, Statutes of 2019

AB-1313 (Luz Rivas) - Higher education: prohibited debt collection practices.

Establishes the Educational Debt Collection Practices Act and prohibits any public or private postsecondary school from withholding a transcript for a current or former student on the grounds that the student owes debt. Chaptered.

Status: Chapter 518, Statutes of 2019

AB-1662 (Ramos) - Native Americans: repatriation.

Expands the membership of the University of California's systemwide Native American Graves Protection and Repatriation Act Implementation and Oversight Committee, from two to three voting members from a tribe located in California and thereby, increasing the Committee's overall membership to eight individuals (one-nonvoting). Chaptered.

Status: Chapter 112, Statutes of 2019

AB-1684 (Maienschein) - Pupil literacy: statewide professional learning infrastructure.

Requires the California Department of Education (CDE) to develop and implement a professional development program to support educators in teaching literacy and reading, including providing dedicated funds to schools identified by the state's accountability system as needing special English language arts (ELA) support, consistent with the state's "system of support" for schools. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

ACCOUNTABILITY AND COORDINATION

SB-3 (Allen) - Office of Higher Education Coordination, Accountability, and Performance.

Establishes the Office of Higher Education Coordination, Accountability and Performance as California's independent coordination, oversight and planning entity for postsecondary education. The office is to provide information and advice to the Governor, Legislature, institutions of postsecondary education and others on various higher education-related issues, including the need for new campuses or academic programs. The bill was held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

AB-130 (Low) - Postsecondary education: Higher Education Performance and Accountability Commission.

Establishes the Higher Education Performance, Accountability and Coordination Commission as the state's independent postsecondary education coordination and agency. The bill was vetoed.

Status: Assembly-Vetoed

AB-1703 (Bloom) - University of California: California Collaborative for Neurodiversity and Learning.

Establishes, subject to appropriation, a collaboration between the University of California and the California State University to apply brain research to the diverse learning needs of children in K-12 education. The bill was subsequently amended to relate to residential real property. The bill was held in Senate Judiciary.

Status: Senate-Died - Judiciary

AB-1729 (Smith) - Pupils: attendance at community college.

Authorizes, until January 2027, additional high school students who meet certain conditions to enroll in summer community college courses by exempting those students from counting toward the five percent enrollment cap imposed by current law. Chaptered.

Status: Chapter 784, Statutes of 2019

ADMISSIONS AND ELIGIBILITY

SB-776 (Skinner) - College admissions: criminal history inquiry: prohibition.

Prohibits a public or private postsecondary educational institution in this state from inquiring about a prospective student's criminal history on an initial application form or at any time during the admissions process before the institution's final decision is made. The bill was subsequently amended to relate to peace officers. Senate floor, inactive file.

Status: Senate-Died

AB-239 (Salas) - Community colleges: registered nursing programs.

Extends, by five years from January 1, 2020, to January 1, 2025, the sunset date on an authorization granted to a community college for admitting students, in accordance with the prescribed procedure, into a registered nursing program in instances when the number of applicants exceeds that program's capacity. Chaptered.

Status: Chapter 83, Statutes of 2019

AB-1383 (McCarty) - Public postsecondary education: admission by exception.

Establishes a process, in statute, for the University of California and the California State University to use when granting, "admission by exception," by prohibiting a campus from using the "admission by exception," policy unless the student's admission has been approved by at least three senior campus administrators. The bill also, requires a campus that uses "admissions by exception," to document each evaluator as well as, establish acceptable rationale for the use of the policy. The bill further, requires a campus that admits a student into a special talent program to establish a policy that requires participation for a minimum of one academic year. When heard by this Committee, the bill solely prohibited a campus from admitting an applicant by "admission by exception," unless the applicant is a California resident who is receiving an institution-based scholarship to attend the campus. Chaptered.

Status: Chapter 522, Statutes of 2019

AB-1729 (Smith) - Pupils: attendance at community college.

Authorizes, until January 2027, additional high school students who meet certain conditions to enroll in summer community college courses by exempting those students from counting toward the five percent enrollment cap imposed by current law. Chaptered.

Status: Chapter 784, Statutes of 2019

AB-1930 (Medina) - Public postsecondary education: University of California and California State University: student eligibility policy.

Requires the California State University Trustees and requests the University of California Regents, to engage in a specified process before adding any undergraduate student eligibility requirements. The bill was held in Senate Appropriations Committee.

Status: Senate-Died - Appropriations

ASSESSMENT

AB-1234 (Patterson) - Standardized tests.

Revises the calculation for the requirement for college admissions-related standardized test sponsors to disclose certain test materials from not fewer than 50 percent of regular test administrations, as rounded to nearest larger whole number, to 50 percent of regular test administrations, as rounded down to the nearest whole number. Chaptered.

Status: Chapter 288, Statutes of 2019

ACR-64 (McCarty) - California State University and University of California: SAT and ACT.

Requests the Trustees of the California State University (CSU) and the Regents of the University of California (UC) to conduct a study on the usefulness, effectiveness, and

need for the Scholastic Aptitude Test (SAT) and the American College Test (ACT) to determine student admissions, including the evaluation of specified matters and recommendations, and a plan, if determined to be necessary, for phasing out the use of the SAT and ACT as a basis for admission. Chaptered.

Status: Chapter 148, Statutes of 2019

ATHLETICS AND PHYSICAL EDUCATION

SB-206 (Skinner) - Collegiate athletics: Fair Pay to Play Act.

Authorizes college student athletes, commencing on January 1, 2023, to earn compensation for the use of their own name, image, or likeness and also obtain professional representation such as a sports agent, in relation to their college athletics. Chaptered.

Status: Chapter 383, Statutes of 2019

AB-1518 (Chu) - Student athletes: contracts.

Authorizes a student athlete to enter into a contract with an athlete agent without losing their status as a student athlete, if the contract complies with the policy of the student athlete's educational institution and the bylaws of the National Collegiate Athletic Association (NCAA). Chaptered.

Status: Chapter 222, Statutes of 2019

AB-1573 (Holden) - Collegiate athletes: Student Athlete Bill of Rights.

(1) Requires institutions of higher education to provide student athletes with specified information, including information detailing certain rights; (2) authorizes institutions of higher education to establish a degree completion fund; and (3) prohibits institutions of higher education from intentionally retaliating against a student athlete, as specified. Chaptered.

Status: Chapter 382, Statutes of 2019

CAREER AND TECHNICAL EDUCATION HIGHER ED

SB-462 (Stern) - Community colleges: Forestland Restoration Workforce Program.

Requires the Chancellor's Office of the California Community Colleges (CCC), in collaboration with the Academic Senate for California Community Colleges (ASCCC), to develop a forest and woodlands restoration workforce model curriculum and vocational programs to be offered by community college districts by July 31, 2021. Held in Assembly Appropriations.

Status: Assembly-Died – Appropriations

SB-563 (Roth) - Community colleges: College and Career Access Pathways Pilot Program.

Establishes the College and Career Access Pathways (CCAP) Grant Program to provide grants on a competitive basis with the goal of demonstrating effective models of fully funded CCAP programs. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-586 (Roth) - College and Career Access Pathways partnerships.

Requires the governing board of a school and community college district, as part of a career technical education College and Career Access Pathways (CCAP) partnership, to consult with the appropriate local workforce development board to determine the extent to which the pathway is aligned with regional and statewide employment needs.

Chaptered.

Status: Chapter 529, Statutes of 2019

SB-716 (Mitchell) - Juveniles: postsecondary and career technical education.

Requires each county probation department as well as the Department of Juvenile Justice (DJJ) to ensure that youths with a high school diploma or California high school equivalency certificate who are detained in, or committed to, their respective facilities, have access to various public postsecondary academic and career technical courses and programs, as specified. Chaptered.

Status: Chapter 857, Statutes of 2019

AB-30 (Holden) - Community colleges: College and Career Access Pathways partnerships.

Extends the College and Career Access Pathways (CCAP) program for an additional five years and simplifies the process for developing CCAP partnerships, as specified.

Chaptered.

Status: Chapter 510, Statutes of 2019

AB-2019 (Holden) - Pupil instruction: College and Career Access Pathways partnerships: county offices of education.

Authorizes County Offices of Education (COEs) to enter into College and Career Access Pathways (CCAP) partnerships with California Community College (CCC) districts. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

COMMUNITY COLLEGE FUNDING

AB-720 (Muratsuchi) - Community colleges: funding: instructional service agreements with public safety agencies.

Funds community college courses offered through an instructional service agreement with a public safety agency at a specified apportionment rate rather than according to the new Student Success Funding Formula. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-1727 (Weber) - Community colleges: career development and college preparation courses.

Allows the funding determination for career development and college preparation (CDCP) courses to be calculated based on either ongoing attendance counts or a census date count, as specified. The bill was vetoed.

Status: Assembly-Vetoed

CONTRACTS HIGHER EDUCATION

SB-715 (Galgiani) - University of California retirement plans: asset managers: contracts.

Prohibits the University of California from entering into a contract for services with an asset manager for a defined contribution plan if that plan is a stand-alone optional plan.

Failed passage in Senate Education

Status: Senate-Died - Education

SB-1444 (Durazo) - California State University: food service contracts and hotel development projects.

Requires the trustees of the California State University (CSU) to ensure that a labor peace agreement be incorporated into each food service contract and hotel development project. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

FOSTER AND HOMELESS STUDENTS

SB-958 (Leyva) - Public postsecondary education: support services for foster youth: Cooperating Agencies Foster Youth Educational Support Program.

Expands eligibility for priority enrollment for current and former foster youth at the University of California, California State University, and California Community Colleges,

and expands eligibility for a student support program for current and former foster youth at the community colleges. The bill was passed by Senate Education but not heard by Senate Human Services due to the shortened 2020 Legislative Calendar.

Status: Senate-Died – Education

AB-16 (Luz Rivas) - Homeless children and youths: reporting.

Adds 1.5 positions within the California Department of Education (CDE) to fulfill duties required of the Coordinator for Education of Homeless Children, and requires the CDE to allocate funds to three county offices of education to establish technical assistance centers relative to the education of homeless children. Vetoed

Status: Assembly-Vetoed

AB-302 (Berman) - Parking: homeless students.

Requires, by July 1, 2020, that a community college campus allow overnight access to its parking facilities to students who are homeless, enrolled coursework, have paid enrollment fees if not waived, and are in good standing with that college. Senate floor, inactive file.

Status: Senate-Died

AB-806 (Bloom) - Postsecondary education: homeless and former homeless youth.

Eliminates the January 1, 2020, sunset date on the granting of priority enrollment for homeless students in the California State University and community colleges, and extends this priority to formerly homeless youth, thereby extending priority enrollment for homeless and formerly homeless students into perpetuity. This bill also extends to former homeless youth several benefits and protections that are currently afforded to current and former foster youth and currently homeless students. Chaptered.

Status: Chapter 163, Statutes of 2019

AB-1229 (Wicks) - End Foster Youth Student Hunger in California Act of 2019.

Requires the California Student Aid Commission (CSAC) to determine how much funding authority is needed for CSAC to establish a Transition Age Foster Youth Meal Plan Program and to report this information to the Legislature. This bill would also require the Department of Social Services (CDSS) to establish an official approval process to ensure that foster youth who participate in an internship may apply those work hours toward meeting eligibility standards as a student in the CalFresh program. CDSS would be required to provide a state-funded cash benefit for nonminor dependents in a supervised independent living placement, as specified. Additionally, this bill would require CDSS to issue guidance to county human services departments to increase CalFresh application and participation rates of exiting foster youth. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-2416 (Gabriel) - Postsecondary education: student financial aid: satisfactory academic progress.

Requires institutions of higher education to allow students to appeal their loss of certain student financial aid if they fail to meet "satisfactory academic progress" due to homelessness. Chaptered.

Status: Chapter 285, Statutes of 2020

GOVERNANCE HIGHER EDUCATION

SB-2 (Glazer) - Statewide Longitudinal Student Database.

Requires the Office of Higher Education Coordination, Accountability, and Performance (the Office) to convene a review committee to advise the Office regarding the creation of a statewide longitudinal student database. Held in Assembly Higher Education

Status: Assembly-Died - Education

AB-514 (Medina) - Trustees of the California State University: student members.

Increases the number of student members of the California State University, Board of Trustees with voting rights by removing the non-voting status of one of the two student members and thereby giving both students the ability to vote. Chaptered.

Status: Chapter 61, Statutes of 2019

AB-930 (Gloria) - California State University: executive compensation: campus budget quarterly reporting.

Prohibits the California State University from approving an increase in executive compensation in a year in which there is a tuition increase, requires a proposed increase in executive compensation or change to compensation policies or procedures to be included as an informational item on the Board of Trustees meeting agenda and voted on publicly in a subsequent meeting, and requires biennial reporting to compare the budgets of each campus to actual spending levels. Held in Senate Appropriations

Status: Senate-Died - Appropriations

AB-1150 (Gloria) - Community college districts: governing board elections: San Diego Community College District: Grossmont-Cuyamaca Community College District.

Requires candidates for election as members of the governing boards of the San Diego Community College District and the Grossmont-Cuyamaca Community College District to file nominating papers. Chaptered.

Status: Chapter 624, Statutes of 2019

AB-2190 (Medina) - Board of Governors of the California Community Colleges.

Eliminates the prohibition against a student member voting during the student member's first year on the Board of the Governors of the California Community Colleges, and makes technical conforming changes. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

INSTRUCTION AND CURRICULUM

SB-777 (Rubio) - Community colleges: full-time instruction.

Modifies provisions relating to the percent of credit instruction taught by full-time faculty at the California Community Colleges by statutorily requiring districts below the 75 percent threshold to annually reduce by 5 percent the deficit between their existing full-time faculty percentage and the 75 percent goal, rather than applying a portion of their "program improvement" funds toward reaching that 75 percent goal. When heard by this Committee, the bill required that the deficit be reduced by a greater percentage. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

Status: Assembly-Vetoed

AB-1393 (Weber) - Pupil instruction: model curriculum: Laotian history and cultural studies.

Adds Laotian history and cultural studies to the forthcoming model curriculum in Hmong history and cultural studies that the Instructional Quality Commission (IQC) is required to develop and submit to the State Board of Education (SBE) by December 31, 2023, and that the SBE is required to adopt, modify, or reject by March 31, 2024; and deletes the requirement for the SBE to provide written rationale if it modifies the model curriculum. The bill was vetoed.

Status: Assembly-Vetoed

AB-1552 (Ramos) - Pupil instruction: Native American studies: model curriculum.

Appropriates eight hundred thousand dollars (\$800,000) to the California Department of Education (CDE) to fund the development by the Instructional Quality Commission (IQC) of a statutorily required model curriculum in Native American studies. The bill was not heard by this committee due to shortened 2020 Legislative Calendar and was subsequently amended to relate to commercial insurance.

Status: Senate-Died - Insurance

AB-2052 (O'Donnell) - Pupil instruction: instructional time requirements.

Authorizes local educational agencies (LEAs) to meet minimum instructional day requirements by both: (1) adding remaining instructional minutes to remaining instructional days in a school year when the LEA is unable to meet instructional day requirements under specified conditions, and (2) submitting affidavits of members of the governing board or body of the school district, county office of education (COE), or charter school, and to the county superintendent of schools. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-2578 (Irwin) - Public postsecondary education: California State University: proficiency level of entering students.

Requires the California State University system to revise an existing report on freshman student proficiency at California State University campuses. It also moves the report deadline and eliminates a currently required interim report. Senate Education, not heard due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

K-12 AND HIGHER EDUCATION FACILITIES

SB-14 (Glazer) - Education finance: Higher Education Facilities Bond Act of 2020.

Places an \$8 billion general obligation bond on the March 2020 ballot for the construction, reconstruction, and remodeling of existing or new facilities at the University of California (UC), the California State University (CSU), and the Hastings College of the Law. Held in Assembly Rules.

Status: Assembly-Died - Rules

SB-56 (Roth) - University of California, Riverside School of Medicine: expansion.

Authorizes the construction of a new University of California, Riverside School of Medicine facility, subject to appropriation. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-297 (Pan) - School facilities: approval of plans.

Allows school and community college districts to award construction contracts, but not perform any construction, prior to receiving plan approval from the State Architect. Held in Assembly Education.

Status: Assembly-Died - Education

SB-743 (Hertzberg) - School facilities: design-build projects.

Clarifies that, upon entering into a design-build contract for a project subject to the California Environmental Quality Act (CEQA), Los Angeles Unified School District shall retain the discretion to terminate the contract before final project design submittal and modify the project as needed to ensure project compliance with CEQA. Chaptered.

Status: Chapter 275, Statutes of 2019

SB-1017 (Portantino) - School facilities: proceeds from sale or lease of surplus property: affordable rental housing facilities.

Limits which school districts are exempt from existing laws related to the sale, lease, or exchange of school property to districts that plan to provide affordable rental housing for their employees and provides these districts with additional flexibility in how their sale or lease proceeds can be used. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1355 (Durazo) - California Community Colleges: affordable housing.

Expands the ways in which a community college districts can enter a joint occupancy agreement with a private person, firm, or corporation to provide its students and employees with affordable housing developments. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-48 (O'Donnell) - Education finance: school facilities: Public Preschool, K-12, and College Health and Safety Bond Act of 2020.

Makes changes to the existing School Facility Program and places the Public Preschool, K-12, and College Health and Safety Bond Act on the March 3, 2020 primary ballot. Chaptered.

Status: Chapter 530, Statutes of 2019

AB-356 (Santiago) - Los Angeles Community College District: best value procurement: pilot program.

Provides for a five-year pilot program for the Los Angeles Community College District to use best value procurement for projects over \$1 million. Chaptered.

Status: Chapter 173, Statutes of 2019

AB-452 (Mullin) - Childcare: facilities: grants.

Establishes the "California Childcare Facilities Grant Fund" (CCFGF) to replace the Child Care Facilities Revolving Fund (CCFRF) and to supply grants to providers of publicly-funded child care for the improvement or construction of facilities to house programs for infants and toddlers. Senate Education, not heard.

Status: Senate-Died - Education

AB-695 (Medina) - Community college facilities: design-build contracts.

Extends the authority for community college districts to enter into design-build public works contracts. Chaptered.

Status: Chapter 492, Statutes of 2019

AB-1303 (O'Donnell) - School facilities: Civic Center Act: direct costs.

Extends the sunset date by five years on the authority for school districts to charge an entity a fee for the use of the school's facilities or grounds that includes the costs for a proportion of the operating and maintenance costs. Chaptered.

Status: Chapter 541, Statutes of 2019

AB-1578 (Luz Rivas) - School Pavement to Parks Grant Program.

Establishes the School Pavement to Parks Grant Program to assist schools located in disadvantaged communities to convert existing pavement to green space. The bill was vetoed.

Status: Assembly-Vetoed

AB-1981 (Nazarian) - Los Angeles Unified School District: best value procurement.

Extends the authority for the Los Angeles Unified School District (LAUSD) to use the best value procurement method by five years, from January 1, 2021, to January 1, 2026. Chaptered.

Status: Chapter 46, Statutes of 2020

OTHER LEGISLATION HIGHER EDUCATION

SB-206 (Skinner) - Collegiate athletics: Fair Pay to Play Act.

Authorizes college student athletes, commencing on January 1, 2023, to earn compensation for the use of their own name, image, or likeness and also obtain professional representation such as a sports agent, in relation to their college athletics. Chaptered.

Status: Chapter 383, Statutes of 2019

SB-383 (Committee on Education) - Postsecondary education: omnibus bill.

Proposes technical, non-controversial amendments to existing law. Specifically, it replaces references to "homemaking" courses at the California Community Colleges with "family and consumer sciences." It also corrects a drafting error in the definition of "Armed Forces of the United States" to include all branches of the California National Guard for purposes of charging resident tuition at public institutions of higher education. The bill was the annual higher education omnibus clean-up bill. Chaptered.

Status: Chapter 77, Statutes of 2019

SB-426 (Bradford) - California State University, Dominguez Hills: Dymally Fellows Project.

Requires the California State University to establish the Dymally Fellows Project to provide academic and leadership skills to students who reside in specified areas of the state. Held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

SB-568 (Portantino) - Public holidays: Armenian Genocide Remembrance Day.

Authorizes Glendale Community College to close on April 24 to observe Armenian Genocide Remembrance Day. Chaptered.

Status: Chapter 648, Statutes of 2019

SB-1155 (Hertzberg) - Community colleges: Los Angeles County Community Colleges Common Course Numbering Pilot Project.

Creates a new common course-numbering effort within the California Community Colleges by requiring the Chancellor to convene a task force to develop a new common course numbering pilot project for colleges located in Los Angeles County. The bill additionally requires that the taskforce complete its work no later than December 31, 2021. The bill was not heard in this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-320 (Quirk) - Pest control: mosquito abatement.

Establishes the California Mosquito Surveillance and Research Program, administered by the University of California, Davis, and outlines the duties of the program. Chaptered.

Status: Chapter 422, Statutes of 2019

AB-521 (Berman) - Physicians and surgeons: firearms: training.

Requires, to the extent the Regents of the University of California adopt a resolution making this requirement applicable, the University of California Firearm Violence Research Center at UC Davis to develop multifaceted education and training programs for medical and mental health providers on the prevention of firearm-related injury and death. Chaptered.

Status: Chapter 728, Statutes of 2019

AB-963 (Petrie-Norris) - Public postsecondary education: Student Civic and Voter Empowerment Act.

Establishes the Student Civic and Voter Empowerment Act to be administered by the Secretary of State, which requires each campus of the California Community Colleges and the California State University, to provide students with specified civic and election

dates and information, and designate one person per campus as a Civic and Voter Empowerment Coordinator. Chaptered.

Status: Chapter 559, Statutes of 2019

AB-1155 (Rodriguez) - Postsecondary education: Campus-Affiliated Sorority and Fraternity Transparency Act.

Requires an institution of higher education to collect and post on its campus website annually, beginning July 1, 2022, a report containing information about its campus-affiliated sorority and fraternity. First, each campus-affiliated sorority or fraternity is to provide basic information for the report, including the organization's participation, grade point averages of members and fundraising information. The bill also, encourages each non-campus-affiliated sorority or fraternity with 50 percent of its members enrolled at a given institution to report this basic information. The institution is to add additional information to the report, including outcomes of allegations of (a) misconduct and (b) the number of citations or disciplinary actions taken related to sexual assault. Senate Education, not heard.

Status: Senate-Died - Education

AB-1460 (Weber) - California State University: graduation requirement: ethnic studies.

Requires the California State University (CSU), commencing with the 2021-22 academic year, to (1) provide courses in ethnic studies at each of its campuses; and (2) require, as an undergraduate graduation requirement commencing with students graduating in the 2024-25 academic year, the completion of, at minimum, one three-unit course in ethnic studies. Chaptered.

Status: Chapter 32, Statutes of 2020

AB-1512 (Carrillo) - Public postsecondary education: community colleges: course credit for passage of International Baccalaureate examination.

Requires the California Community College Chancellor's Office, in collaboration with the Academic Senate for California Community Colleges, to develop a policy relating to awarding academic credit for a score of four or more on an International Baccalaureate subject examination. The bill was subsequently amended to relate to security officers. Chaptered.

Status: Chapter 343, Statutes of 2020

AB-1518 (Chu) - Student athletes: contracts.

Authorizes a student athlete to enter into a contract with an athlete agent without losing their status as a student athlete, if the contract complies with the policy of the student athlete's educational institution and the bylaws of the National Collegiate Athletic Association (NCAA). Chaptered

Status: Chapter 222, Statutes of 2019

AB-1573 (Holden) - Collegiate athletes: Student Athlete Bill of Rights.

(1) Requires institutions of higher education to provide student athletes with specified information, including information detailing certain rights; (2) authorizes institutions of higher education to establish a degree completion fund; and (3) prohibits institutions of higher education from intentionally retaliating against a student athlete, as specified. Chaptered.

Status: Chapter 382, Statutes of 2019

AB-3374 (Committee on Higher Education) - Postsecondary education.

Corrects technical errors and oversights, and makes non-controversial changes to various provisions of the Education Code. The bill was the higher education omnibus clean-up measure. Chaptered.

Status: Chapter 129, Statutes of 2020

ACR-64 (McCarty) - California State University and University of California: SAT and ACT.

Requests the Trustees of the California State University (CSU) and the Regents of the University of California (UC) to conduct a study on the usefulness, effectiveness, and need for the Scholastic Aptitude Test (SAT) and the American College Test (ACT) to determine student admissions, including the evaluation of specified matters and recommendations, and a plan, if determined to be necessary, for phasing out the use of the SAT and ACT as a basis for admission. Chaptered.

Status: Chapter 148, Statutes of 2019

PRIVATE POSTSECONDARY EDUCATION

SB-634 (Glazer) - Education.

Eliminates the requirement that the Bureau for Private Postsecondary Education transmit any available data regarding school performance, including, but not limited to, attendance and graduation rates, to the California Postsecondary Education Commission. The bill was subsequently amended to relate to container recycling. Held in Assembly Rules.

Status: Assembly-Died - Rules

AB-1340 (Chiu) - Private postsecondary education: California Private Postsecondary Education Act of 2009: labor market outcome data reporting.

Requires institutions regulated by the Bureau for Private Postsecondary Education to report identifying, program enrollment, and loan debt information to the Bureau. This bill authorizes Bureau to match student information with wage data provided by the Employment Development Department. This bill also requires the Bureau to make information available on its Web site when the Director of the Department of Consumer

Affairs certifies that an updated information technology system is capable of processing data. Chaptered.

Status: Chapter 519, Statutes of 2019

AB-1341 (Berman) - Private postsecondary education: California Private Postsecondary Education Act of 2009.

Prohibits the Bureau for Private For-Profit Postsecondary Education from verifying an exemption from Bureau oversight for a nonprofit that operated as a for-profit institution unless the Attorney General makes certain determinations. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-1342 (Low) - Nonprofit corporations: private postsecondary educational institutions: sale of assets: Attorney General approval.

Requires a nonprofit corporation that operates or controls a private postsecondary educational institution to obtain the Attorney General's consent before entering into certain agreements or transactions, including an agreement or transaction to sell or convey its assets to, or to transfer control, responsibility, or governance of a material amount of its assets to, a for-profit corporation or mutual benefit corporation. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-1344 (Bauer-Kahan) - Private postsecondary education: California Private Postsecondary Act of 2009.

Replaces, beginning July 1, 2022, current requirements for the information out-of-state institutions are required to provide the Bureau for Private Postsecondary Education if they enroll California students in online programs, with the same and expanded information requirements, specifically adding adverse actions to the list of information that has to be provided. This bill also authorizes the Bureau to place these out-of-state private postsecondary institutions on a probationary status and revoke authorization to enroll California students. Chaptered.

Status: Chapter 520, Statutes of 2019

AB-1345 (McCarty) - Private postsecondary education: California Private Postsecondary Education Act of 2009.

Establishes and revises existing restrictions on private postsecondary school institutions from providing specified financial incentives, compensation, commission, bonus, or payment contingent upon quotas based on securing student enrollments, admissions, financial aid awards, or sales of educational materials. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-1346 (Medina) - Postsecondary education: California Private Postsecondary Education Act of 2009: Student Tuition Recovery Fund.

Expands the definition of economic loss to include all amounts paid by a student to the institution, any amounts paid in connection with attending the institution, and all principal, interest, and charges of any kind for any loan incurred by the student to pay these amounts and expands Student Tuition Recovery Fund eligibility to students residing in California and attending a campus of a Corinthian Colleges, Inc., institution on or after January 1, 2010. Chaptered.

Status: Chapter 521, Statutes of 2019

AB-2030 (Blanca Rubio) - Student financial aid: Cal Grant Program.

Establishes a formula to determine the amount of Cal Grant awards for students attending California independent, nonprofit colleges and universities. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

PROGRAMS/NEW CAMPUSES

SB-56 (Roth) - University of California, Riverside School of Medicine: expansion.

Authorizes the construction of a new University of California, Riverside School of Medicine facility, subject to appropriation. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-444 (Umberg) - University of California: Berkeley and Irvine law schools: Pro Se Indigent Litigant Pilot Project.

Requests the Regents of the University of California to enact a resolution authorizing the law schools at University of California, Berkeley and University of California, Irvine to participate in a research program to develop artificial intelligence (AI) or machine-learning solutions to address access to justice issues faced by self-representing litigants in their respective courts. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-874 (Hill) - Public postsecondary education: community colleges: statewide baccalaureate degree pilot program.

Authorizes the Board of Governors of the California Community Colleges in consultation with the California State University and University of California to establish an unlimited number of district baccalaureate degree programs, allows the 15 existing community college baccalaureate degree pilot programs to continue to operate, and eliminates the January 1, 2027 repeal of the statewide pilot program thereby making the authorization

permanent. The bill was not heard in this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-829 (Bloom) - California State University: Doctor of Occupational Therapy Program.

Authorizes the California State University to establish Doctor of Occupational Therapy degree programs that are distinguished from doctoral degree programs at the University of California. Chaptered.

Status: Chapter 183, Statutes of 2019

AB-1075 (Holden) - California State University: speech-language pathologist programs.

Requires the Chancellor of the California State University to allocate funds to campus speech-language pathologist programs to expand enrollment in those programs. The bill was vetoed

Status: Assembly-Vetoed

AB-1703 (Bloom) - University of California: California Collaborative for Neurodiversity and Learning.

Establishes, subject to appropriation, a collaboration between the University of California and the California State University to apply brain research to the diverse learning needs of children in K-12 education. The bill was subsequently amended to relate to residential real property. Held in Senate Judiciary.

Status: Senate-Died - Judiciary

SAFE SCHOOLS AND PUPIL PROTECTION

AB-1153 (Wicks) - Mandated Child Abuse Reporting Employee Training Act of 2020.

Establishes the Mandated Child Abuse Reporting Employee Training Act of 2020, requiring each governing board of a California Community College (CCC) district to annually train employees and administrator of the district who are mandated reporters on mandated reporting requirements, develop a process for individuals required to receive the training to provide proof of completion, and develop a process to identify students who are minors enrolled in classes at the district and provide that information to faculty members and employees who are mandated reporters. The bill was vetoed.

Status: Assembly-Vetoed

STAFFING AND ADMINISTRATION HIGHER EDUCATION

SB-660 (Pan) - Postsecondary education: mental health counselors.

Requires the California State University, Board of Trustees and Board of Governors of the California Community Colleges to establish a goal of having one mental health counselor per 1,500 students enrolled at each of their respective campuses. When heard by this Committee, the bill required campuses to have, rather than establish, a goal of that same ratio. Held in Assembly Appropriations.

Status: Assembly-Died - Appropriations

AB-369 (Weber) - Public postsecondary education: California State University: support staff employees: merit salary adjustments.

Requires each support staff employee of the California State University (CSU) to receive an annual five percent merit salary adjustment upon meeting the standards for satisfactory performance in their position. Senate Floor, inactive file.

Status: Senate-Died

AB-463 (Cervantes) - Community colleges: faculty members: loan forgiveness.

Requires that the Community College Chancellor's Office develop materials to increase awareness of the federal Public Service Loan Forgiveness program for faculty and requires a community college district to annually provide an enrolled faculty member with notice of renewal and a copy of the employment certification form with the employer portion of the form already completed. The bill additionally, requires a community college district to make certain determinations relative to the work completed by faculty members for purposes of the program. Chaptered

Status: Chapter 512, Statutes of 2019

AB-706 (Low) - Community colleges: academic employees.

Removes circumstances for which, an academic employee of a community college district of at least one school year, is entitled to transfer accrued leave to another district. Chaptered.

Status: Chapter 100, Statutes of 2019

AB-897 (Medina) - Community colleges: part-time employees.

Increases, unless explicitly agreed upon, the maximum number of instructional hours a part-time, temporary California Community College (CCC) faculty member may teach. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

ACA-14 (Gonzalez) - University of California: support services: equal employment opportunity standards.

Amends Article IX of the State Constitution by adding Section 9.5, the University of California (UC) Equal Employment Opportunity Standards Act, requiring the Regents of the UC to ensure that all contract workers who are paid to perform support services are afforded the same equal employment opportunity standards as university employees performing similar services. Senate Floor, inactive file.

Status: Senate-Died

STAFFING AND ADMINISTRATION/COLLECTIVE BARGAINING

SB-390 (Umberg) - School districts and community college districts: school security officers and security guards.

Requires all security guards working on school and community college campuses to complete the latest training developed by the Department of Consumer Affairs and specifies that local educational agencies must provide the training to all security guards during their regular work hours. Chaptered.

Status: Chapter 475, Statutes of 2019

SB-428 (Pan) - Teachers: youth mental health first aid.

Requires the California Department of Education (CDE) to identify an evidence-based training program for local educational agencies to use to train classified and certificated school employees having direct contact with pupils in youth mental and behavioral health. The bill was vetoed.

Status: Senate-Vetoed

SB-796 (Leyva) - School and community college employees: absences due to illness or accident.

Requires certificated and classified school and community college employees who have exhausted all sick leave to continue to receive their full pay while out on extended leave due to illness or injury. The bill was not heard by this committee due to shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-805 (Portantino) - School employees: leaves of absence: natural disasters and evacuation orders.

Prohibits school districts from requiring employees to use their paid leave if they are unable to report to work because the school is forced to close as a result of a natural disaster or an evacuation order. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

AB-500 (Gonzalez) - School and community college employees: paid maternity leave.

Requires that school districts, charter schools, and community colleges provide at least six weeks of full pay for pregnancy-related leaves of absence taken by certificated, academic, and classified employees. The bill was vetoed.

Status: Assembly-Vetoed

AB-1859 (Santiago) - School district employees: merit system: appointments.

Extends the authority for the Los Angeles Unified School District (LAUSD) to fill a classified vacancy with an applicant who is not among the first three ranks of an eligibility list, as specified, until January 1, 2027. Chaptered.

Status: Chapter 67, Statutes of 2020

STUDENT BASIC NEEDS HOUSING AND HUNGER

SB-467 (Monning) - Postsecondary education: cost-of-living categories.

Expands the type of information relative to costs of living off-campus that is currently required to be posted on the Web site for the California State University, and requested to be posted on the Web site of the University of California. Chaptered.

Status: Chapter 527, Statutes of 2019

SB-728 (Galgiani) - Student financial aid: housing and hunger hardship.

Establishes the Student Housing and Food Hardship Fund for the California Student Aid Commission to establish a program under which students attending a public postsecondary educational institution who are experiencing housing or food hardship may apply for emergency assistance. Held in Senate Appropriations

Status: Senate-Died - Appropriations

AB-521 (Berman) - Physicians and surgeons: firearms: training.

Requires, to the extent the Regents of the University of California adopt a resolution making this requirement applicable, the University of California Firearm Violence Research Center at UC Davis to develop multifaceted education and training programs for medical and mental health providers on the prevention of firearm-related injury and death. Chaptered.

Status: Chapter 728, Statutes of 2019

AB-612 (Weber) - CalFresh: Restaurant Meals Program.

Expands the existing authority for the Department of Social Services to enter into a memorandum of understanding to prevent hunger among college students who are homeless to include the California Community Colleges (CCCs), and expands

participation in the CalFresh Restaurant Meals Program to include qualifying food facilities that are located on a campus of the CCCs. Chaptered
Status: Chapter 804, Statutes of 2019

AB-943 (Chiu) - Community colleges: Student Equity and Achievement Program funds.

Authorizes the use of funding from the Student Equity and Achievement Program at the California Community Colleges for emergency student financial assistance to help an eligible student overcome unforeseen financial challenges that would directly impact the student's ability to persist in their course of study. Chaptered.

Status: Chapter 515, Statutes of 2019

AB-1278 (Gabriel) - Public postsecondary educational institutions: public services and programs: internet website notification.

Requires each campus of the California State University and the California Community Colleges to include information about specified public services and programs on students' Web-based student accounts. Chaptered.

Status: Chapter 517, Statutes of 2019

AB-2388 (Berman) - Public postsecondary education: basic needs of students.

Requires each California Community College campus by February 1, 2021, to develop various methods to increase students' awareness of on- and off- campus basic needs resources. Encourages each CCC campus by July 1, 2021, to establish a Basic Needs Center and the role of a Basic Needs Coordinator, in order to consolidate and centralize the basic needs resources available on campus. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

STUDENT FEES/CAL GRANTS

SB-52 (Atkins) - The Cal Grant Program: Cal Grant C awards.

Statutorily establishes September 2 as the Cal Grant C application submission deadline commencing with the 2020–21 academic year. Held in Senate Appropriations.

Status: Senate-Died - Appropriations

SB-296 (Allen) - Student financial aid: immigrants seeking asylum.

Extends eligibility to the Cal Grant program, for students who are noncitizens and who have filed for a specific type of asylum, to the same extent as citizens and other eligible noncitizens, as provided under current law. The bill was vetoed.

Status: Senate-Vetoed

SB-461 (Roth) - Student financial aid: Cal Grants: summer term students.

Expands the total period of eligibility for Cal Grant awards by allowing a Cal grant A or Cal Grant B award recipient to receive up to two summer term Cal Grant awards. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-575 (Bradford) - Cal Grants: student eligibility.

Deletes provisions that prohibit a student who is incarcerated from being eligible for a Cal Grant award and thereby, extending eligibility to incarcerated persons to the same extent as the general population. The bill was vetoed.

Status: Senate-Vetoed

AB-1307 (Blanca Rubio) - Student financial aid: Cal Grant program.

Creates, beginning in the 2020-21 award year, a new Cal Grant formula for nonprofit independent institutions of higher education. The formula is to be set and maintained at 80 percent of the sum of the General Fund share of the California State University marginal cost of instruction and the maximum Cal Grant award for tuition at the California State University. The bill was vetoed.

Status: Assembly-Vetoed

AB-1314 (McCarty) - Student financial aid: Cal Grant Reform Act.

Enacts the Cal Grant Reform Act, which reforms the state's Cal Grant student financial aid programs and creates the summer Cal Grant program. The bill was subsequently amended to relate to law enforcement. Held in Senate Public Safety.

Status: Senate-Died - Public Safety

AB-1774 (Bonta) - Student financial aid: Student Aid Commission: extension of application deadlines.

Authorizes the California Student Aid Commission to postpone an application deadline of up to 30 calendar days for any financial aid program it administers for regions that have experienced natural disasters, states of emergency or labor actions. The bill was an urgency measure. Chaptered.

Status: Chapter 524, Statutes of 2019

AB-2030 (Blanca Rubio) - Student financial aid: Cal Grant Program.

Establishes a formula to determine the amount of Cal Grant awards for students attending California independent, nonprofit colleges and universities. The bill was not heard in this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

STUDENT FEES/FINANCIAL AID

SB-150 (Beall) - Student financial aid: Chafee grant awards.

Relaxes the eligibility requirements and appellate process for recipients of the Chafee Educational and Training Vouchers award, which provides financial aid to current and former foster youth who are enrolled in qualifying institutions of higher education. Chaptered.

Status: Chapter 525, Statutes of 2019

SB-291 (Leyva) - Postsecondary education: California Community College Student Financial Aid Program.

Establishes the California Community College Student Financial Aid Program to be administered by the Board of Governors of the California Community College and implemented by eligible community colleges to help cover the total cost of attendance. Held in Assembly Higher Education.

Status: Assembly-Died - Higher Education

SB-354 (Durazo) - California DREAM Loan Program: graduate degree programs.

Expands, commencing with the 2020-21 academic year, eligibility for the California DREAM loan program at the California State University and University of California to a student who is enrolled in a program that leads to a professional or graduate degree provided that the student meets other applicable qualifications. The bill additionally requires that priority be given to loans for undergraduate programs. Chaptered.

Status: Chapter 526, Statutes of 2019

SB-1082 (Dodd) - Student nutrition: eligibility for CalFresh benefits.

Requires that the California Community College Board of Governors adopt regulations so that a student who qualifies for a California College Promis Grant, (formerly known as the BOG fee waiver), and whose household income is below 200 percent of the federal poverty level, may also qualify for CalFresh benefits. The bill further modifies the requirement for notifying certain Cal Grant recipients at any institution of their exemption from the student prohibition rule on CalFresh benefits to include other recipients who may qualify for benefits under other exemptions. The bill was not heard in this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

SB-1402 (Stern) - CalServe.

Establishes the CalServe Higher Education Grant Program, under the administration of the California Student Aid Commission, which would award annual grants to eligible students who serve as volunteers for two years, to finance mandatory systemwide tuition and fees not covered by state, federal and institutionally administered grants or waivers

commencing with the 2023-24 academic year. The bill also, restructures the existing volunteer agency California Volunteers, renamed CalServe as a state agency outside of the Governor's Office and sets forth, among other things, its mission, duties and responsibilities. The bill was not heard in this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-15 (Nazarian) - Student financial aid: California Kids Investment and Development Savings Program.

Establishes, automatically, a Scholarshare 529 college savings account for every child born in California after January 1, 2020, subject to available funding. The bill's contents were amended into SB 77, the higher education budget trailer bill.

Status: Senate-Died - Rules

AB-540 (Limón) - Postsecondary education: student financial aid: Cal Grant B Service Incentive Grant Program.

Changes the name of the Cal Grant B Service Grant Program to the California Dreamer Service Incentive Grant Program and requires that organizations at which service hours are being performed to have been established for a minimum of 2 years. When heard by this Committee, the bill established the original grant program and its contents were subsequently amended into 2019 Budget Act. Chaptered.

Status: Chapter 513, Statutes of 2019

AB-703 (Weber) - Public postsecondary education: fee waivers for exonerated persons.

Prohibits the University of California, the California State University and the California Community Colleges from collecting mandatory systemwide fees or tuition to exonerated persons that has financial need, as defined. Chaptered.

Status: Chapter 436, Statutes of 2019

AB-710 (Cervantes) - Postsecondary education: cost of attendance: fiscal matters.

Establishes the Housing Cost of Attendance Act and requires an institution within the California Community College, California State University, or the University of California system, as well as, an independent and private postsecondary institution to use certain items in its cost-of-attendance calculation. The bill was vetoed.

Status: Assembly-Vetoed

AB-843 (Rodriguez) - Student financial aid: Assumption Program of Loans for Education.

Authorizes the California Student Aid Commission to award 7,200 new warrants for the Assumption Program of Loans for Education. Senate Education, not heard.

Status: Senate-Died - Education

AB-853 (Smith) - Student financial aid: Golden State Scholarshare Trust Act.

Authorizes the Scholarshare Investment Board to make payments to third parties, in addition to institutions of higher education, on behalf of program beneficiaries, and makes conforming changes. Chaptered.

Status: Chapter 17, Statutes of 2019

AB-1090 (Medina) - Public postsecondary education: waiver of mandatory campus-based fees.

Expands an existing exemption from mandatory systemwide tuition and fees at the University of California, the Hastings College of Law, the California State University, and the California Community Colleges for an eligible dependent of active duty law enforcement or firefighters who died in the line of duty, by additionally exempting them from mandatory campus-based fees. Chaptered.

Status: Chapter 516, Statutes of 2019

AB-1504 (Medina) - Community colleges: student representation fee: statewide community college student organization: goals.

Modifies the process for adoption of the student representation fee at a community college. Specifically, this bill eliminates the requirement that a campus election be held in order to establish or terminate the fee assessed on students for representation. Instead the bill, allows direct collection of that fee. Chaptered.

Status: Chapter 523, Statutes of 2019

AB-2416 (Gabriel) - Postsecondary education: student financial aid: satisfactory academic progress.

Requires institutions of higher education to allow students to appeal their loss of certain student financial aid if they fail to meet "satisfactory academic progress" due to homelessness. Chaptered.

Status: Chapter 285, Statutes of 2020

AJR-2 (Voepel) - The federal Pell Grant Program awards.

Calls upon the Congress and the President of the United States to increase the maximum Pell Grant from \$6,195 to at least \$7,500. Chaptered.

Status: Chapter 98, Statutes of 2019

STUDENT SAFETY/HEALTH

SB-24 (Leyva) - Public health: public university student health centers: abortion by medication techniques.

Requires student health centers (SHC) located on a campus within the University of California or California State University that provide primary health care services to students, after January 1, 2023, to offer abortion by medication techniques onsite. Requires the California Commission on the Status of Women and Girls to administer the College Student Health Center Sexual and Reproductive Health Preparation Fund, which is established by this bill for the purposes of providing private moneys to public university SHCs for medication abortion readiness. Chaptered.

Status: Chapter 740, Statutes of 2019

SB-316 (Rubio) - Pupil safety: identification cards: domestic violence hotline telephone numbers.

Requires public schools, including charter schools, commencing October 1, 2020, that serve pupils in any of grades 9 to 12, inclusive, and that issue pupil or student identification cards, to print the telephone number for the National Domestic Violence Hotline on the back of those identification cards; and requires public or private institutions of higher education, that issue pupil or student identification cards, to print the telephone number for the National Domestic Violence Hotline or a local domestic violence hotline that provides confidential support services for students that have experienced domestic violence. When heard by this committee, the bill's commencing date was July 1, 2020. Chaptered.

Status: Chapter 270, Statutes of 2019

SB-366 (Chang) - Public postsecondary education: mandatory orientation for students.

Requires the California State University, and requests the University of California, to provide educational and preventive information about cyberbullying to students as part of established campus orientations, at all campuses of their respective segments.

Chaptered.

Status: Chapter 146, Statutes of 2019

SB-493 (Jackson) - Education: sex equity.

Requires postsecondary educational institutions to, among other things, adopt rules and procedures for the prevention of sexual harassment, and adopt and post on their Web sites the grievance procedures to resolve complaints of sexual harassment. Chaptered.

Status: Chapter 303, Statutes of 2020

AB-381 (Reyes) - Postsecondary education: sexual assault and sexual violence prevention training: intimate partner and dating violence.

Requires outreach programming that is part of every incoming postsecondary education institution student's orientation to include informing students about specific topics relating to intimate partner and dating violence. Chaptered.

Status: Chapter 87, Statutes of 2019

AB-493 (Gloria) - Teachers: lesbian, gay, bisexual, transgender, queer, and questioning pupil resources and training.

Requires the California Department of Education (CDE) develop resources or update existing resources for in-service training on schoolsite and community resources for the support of Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning (LGBTQ) students, for use in local educational agencies (LEAs) and charter schools serving students in grades 7-12. Chaptered.

Status: Chapter 775, Statutes of 2019

AB-624 (Gabriel) - Pupil and student health: identification cards: sexual assault and domestic violence hotline telephone numbers.

Requires public and private schools that serve grades 7-12, and public and private institutions of higher education, that issue student identification cards to print on either side of the cards the telephone numbers for the National Sexual Assault Hotline, and the National Domestic Violence Hotline. The bill was vetoed

Status: Assembly-Vetoed

AB-809 (Santiago) - Public postsecondary education: child development programs: priority enrollment: Title IX protection: pregnancy and parental status.

Requires public postsecondary educational institutions notify pregnant or parenting students of protections provided by Title IX. The bill also encourages child development programs established by public postsecondary educational institutions to give priority to children of students who are single parents. Chaptered.

Status: Chapter 265, Statutes of 2019

AB-1000 (Cervantes) - Student safety.

Requires the governing boards of each community college district, the Trustees of the California State University (CSU), the Board of Directors of the Hastings College of the Law, and the Regents of the University of California (UC), to annually review their written procedure or protocols relating to sexual assault, and to update them as necessary in collaboration with sexual assault counselors and student, faculty, and staff representatives. Chaptered.

Status: Chapter 125, Statutes of 2019

VETERANS AND MILITARY PERSONNEL

AB-2494 (Choi) - Postsecondary education: course credit for prior military education, training, and service.

Requires the California State University, and requests the University of California, to develop and periodically update policies to award military personnel and veteran's course credit. The bill was not heard by this committee due to the shortened 2020 Legislative Calendar.

Status: Senate-Died - Education

AB-3137 (Voepel) - Community colleges: California College Promise: members of the Armed Forces of the United States.

Requires California Community Colleges to allow a student who is a member of the Armed Forces of the United States that is called to active duty to withdraw from participation in the California College Promise fee waiver program and resume receipt of the waiver once they return from duty without penalty. Chaptered.

Status: Chapter 226, Statutes of 2020
