Voices from the Classroom: Developing a Strategy for Teacher Retention and Recruitment

Key findings from a survey of TK-12 teachers in California and in-depth interviews with aspiring and former teachers in California

More than 4,600 TK-12 teachers from around the state took part in the survey in summer 2022. Voices from the Classroom is a representative survey of California teachers that captures the views and opinions of educators on a wide variety of education issues. The purpose of this survey is to provide decision-makers with key insights from untapped classroom experts — teachers. The survey and analysis was conducted by Hart Research Associates on behalf of the California Teachers Association and UCLA Center for the Transformation of Schools.

Data by HART Research Developing a Strategy for Teacher Retention and Recruitment, September 15, 2022, shows that:

- 1 in 3 new teachers think that the TPA had a negative impact.
- Three in five current teachers believe that better and more realistic teacher preparation and assessments should be a top priority for improving teacher retention.

• Aspiring teachers of color report that teacher candidate assessments are racially biased and a major barrier to completing their credential.

CTA Recommendation #6: Reduce financial barriers to pre-service teachers and new teachers.

HART Research Developing a Strategy for Teacher Retention and Recruitment, September 15, 2022

- "The financial costs influenced students' decision to enter, and their ability to finish a teacher preparation program." (Page 4, 14, and 15)
- Compensating student teachers was suggested by a significant number of aspiring teachers that will help alleviate financial stress.
- Aspiring teachers of color reported that they became less motivated to teach at higher rates than their white counterparts due to the financial stress and no pay for student teaching.

<u>CTA Recommendation #7</u>: Encourage people who might be looking to change careers to consider a career in education, especially ECE given the estimated 16,000 credentialed educators need for full UTK implementation by 2025/2026.
